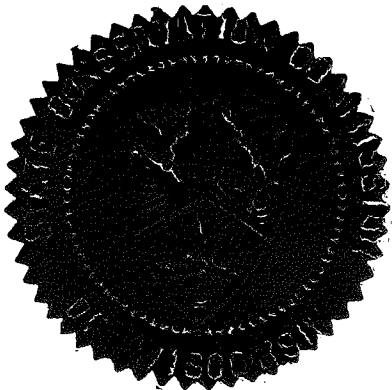

ORDER OF THE STATE CONSERVATION COMMISSION OF WISCONSIN AMENDING RULES

Pursuant to authority vested in the State Conservation Commission of Wisconsin by section 29.17h, Wis. Stats., the State Conservation Commission of Wisconsin hereby amends and adopts rules as follows:

Section MCD 30.01 (h) (d) of the Wisconsin Administrative Code is amended to read:

MCD 30.01 (h) (d) Shawano County
All lands outside of the limits of incorporated cities and villages in:
Township 26 North, Ranges 11, 12 and 13 East;
Township 27 North, Ranges 11, 12 and 13 East;
such portions of sections 1, 12 and 13 lying East of State Trunk Highways 47 and 55 in Range 15 East; sections 1, 2, 3, 4, 5, 6, 7, 8; such portions of sections 9, 10, 11, 12 and 16 lying north of County Trunk Highway "M" and the North 1/2 of Section 17; the North 1/2 and the West 1/2 of the SW1/4 of Section 18 in Range 16 East;
Township 28 North, Ranges 11, 12, and 13 and 14 East;
Township 29 North, Ranges 11 and 12 East.

Section MCD 30.01 (h) (f) of the Wisconsin Administrative Code is created to read:

MCD 30.01 (h) (f) Oconto County
All lands outside of the limits of incorporated cities and villages in:
Township 28 North, all of that part of Range 17 East lying west or north of County Trunk Highways "M" and "NN";
Township 29 North, all of that part of Range 17 East lying west or north of County Trunk Highway "M" and State Trunk Highway 32.



Section WCD 30.01 (9)(e) of the Wisconsin Administrative Code is amended to read:
WCD 30.01 (9)(e) Wood County

All lands outside of the limits of incorporated cities and villages in:
Township 21 North, Ranges 2, 3, 4, 5 and 6 East;
Township 22 North, Ranges 2, 3, 4, 5 and the
East 1/2 of Range 6;
Township 23 North, Range 2 East.

The rules and amendments contained herein shall take effect on May 1, 1962.
