I, Helen E. Gill, Secretary of the Industrial Commission of Wisconsin and custodian of the official records of said commission, do hereby certify that the Industrial Commission on November 12, 1962 voted to repeal order Ind 41.50 A.S.M.E. code vessels of the Boiler and Unfired Pressure Vessel Code and adopt new order Ind 41.50 A.S.M.E. code vessels to read as follows:
