IN THE MATTER OF THE REPEAL OF MVD 11.03 (21) OF THE WISCONSIN ADMINISTRATIVE CODE.

ORDER REPEALING, VACATING AND RESCINDING MVD 11.03 (21), WIS CONSIN ADMINISTRATIVE CODE

MOTICE having been given by publication in the February, 1963 Administrative Register for repealing MVD 11.03 (21), Wisconsin Administrative Code (the provision adding six additional points to each conviction for an incidental personal injury) provided under 343.32 (2), Wisconsin Statutes, and according to the procedure set forth under 227.02 (1) (e), Wisconsin Statutes; and,

The statutory thirty days as set forth in 227.02 (1) (e), Wisconsin Statutes having expired with no petition for a hearing having been filed by 25 persons who will be affected by the repeal of the rule, a municipality which will be affected by the rule, or an association which is representative of a farm, labor, business or professional group which will be affected by the rule, during such thirty-day statutory period;

IT IS HEREBY ORDERED, that MVD 11.03 (21), of the Wisconsin Administrative Code is hereby repealed, vacated and rescinded effective immediately.
