ORDER ADOPTING AMENDED RULES

Notice of proposed amendment of sections PSC 50.02 (8a) and (10), Wisconsin Administrative Code, was published in the February 1963 Notice Section of the Administrative Register. The Commission has received no petition for public hearing as provided for in section 227.02(1)(e), Statutes.

ORDER

THE COMMISSION THEREFORE ORDERS:

1. That pursuant to authority vested in the Public Service Commission by Chapter 194, Wis. Stats., the Public Service Commission amends sections PSC 50.02(8a) and (10), Wisconsin Administrative Code, to read as follows:

PSC 50.02(8a) HIGHWAY 41-Between its  
junction with highway 55 north of Kaukauna  
and De Pere.

PSC 50.02(10) HIGHWAY 50--Between  
highway 41 and Delavan.

2. That certified copies of the above amended rules be filed with the secretary of state and revisor of statutes, as required by section 227.023, Wis. Stats.

3. That the above amended rules become effective May 1, 1963, under the provisions of section 227.026(1), Wis. Stats.
