PSC 50.02(8a) HIGHMAY 41-Between its junction with highway 55 north of Kaukauna and De Pere.

PSC 50.02(10) HIGHWAY 50--Between highway 41 and Delavan.

2. That certified copies of the above amended rules be filed with the secretary of state and revisor of statutes, as required by section 227.023, Wis. Stats.

That the above amended rules become effective
May 1, 1963, under the provisions of section 227.026(1),
Wis. Stats.
