ORDER OF THE
PUBLIC SERVICE COMMISSION OF WISCONSIN

Pursuant to authority vested in the Public Service Commission by section 196.74 and chapter 227, Wis. Stats., the Public Service Commission hereby amends and adopts rules as follows:

Chapter PSC 114 of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

Chapter PSC 114

WISCONSIN STATE ELECTRICAL CODE

PSC 114.01 Wisconsin state electrical code
PSC 114.02 Availability of state electrical code

PSC 114.01 Wisconsin state electrical code. The Wisconsin state electrical code is issued and administered by the public service commission and the industrial commission as part of the Wisconsin Administrative Code. The rules carry the prefix "E" and may be cited as "Wis. Adm. Code E (supply chapter or section number)."

PSC 114.02 Availability of state electrical code. The Wisconsin state electrical code, published in two volume, may be purchased from the same source as other Wisconsin Administrative Code material.

Volumes I and II of the state electrical code, being rules having the prefix "E" and issued jointly by the

Public Service Commission and the Industrial Commission as part of the WISCONSIN ADMINISTRATIVE CODE, are revised to read as shown in said Volumes I and II, attached.

The amendment and rules contained herein shall take affect on May 1, 1964 as provided in section 227.026 (1), Wis. Stats.
