ORDER REPEALING RULES

on February 3, 1964 in its docket 2-U-5931, acting under section 196.60, Wisconsin Statutes, the Public Service Commission of Wisconsin adopted rules, Commissioner Padrutt dissenting, (Chapter PSC 168, sections PSC 168.01 to 168.05, inclusive, Wisconsin Administrative Code) stating under what circumstances telephone service could be provided by telephone public utilities at less than the filed tariff rate. Following denial of applications for rehearing filed by interested parties on February 28, 1964, proceedings were commenced for review of the order of the Public Service Commission of Wisconsin in issuing said rules in the Circuit Court for Dane County, Wisconsin, on March 17, 1964.

Thereafter, Chapter 499, Laws 1963, which amends section 196.60, Wis. Stats., became effective May 8, 1964.

The effect of this legislation is to make inoperative the rules enumerated above.

NOW, THEREFORE, IT IS ORDERED:

That to conform to the statute which has been changed by enactment of Chapter 499, Laws 1963 (section 196.60) effective May 8, 1964, since the adoption of said rules, the Public Service Commission of Wisconsin hereby repeals said rules as follows:

- 1. Chapter PSC 168, consisting of sections PSC 168.01 to 168.05, Wisconsin Administrative Code, inclusive, are repealed in their entirety under the provisions of section 227.02 (1)(b), Wis. Stats.
- 2. The aforesaid repeal shall be effective at the earliest time prescribed by section 227.026, Wis. Stats.

FURTHER ORDERED that certified copies of this document be filed with the Secretary of State and Revisor of Statutes as provided in sections 227.023 and 227.024, Wis. Stats.
