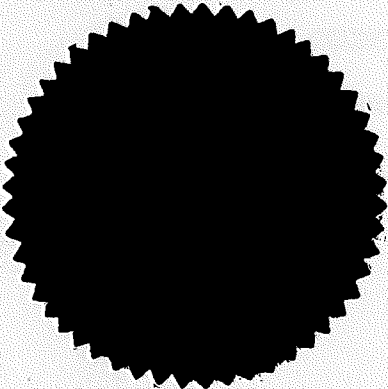

ORDER OF THE STATE CONSERVATION COMMISSION OF WISCONSIN

ADOPTING, AMENDING AND REPEALING RULES

Pursuant to authority vested in the State Conservation Commission of Wisconsin, by sections 23.09, 23.11, 27.01, 28.02 and 28.03, Wis. Stats., the State Conservation Commission of Wisconsin hereby repeals, amends and adopts rules as follows:

Section 1. WCD 40.02 of the Wisconsin Administrative Code is repealed.

Section 2. Chapter WCD 41 of the Wisconsin Administrative Code is created to read:

Chapter WCD 41

STATE PARKS

WCD 41.01 Council Grounds State Roadside Park

(Sections 23.09, 23.11 and 27.01, Wis. Stats.)

WCD 41.01 COUNCIL GROUNDS STATE ROADSIDE PARK. All state-owned park lands now or that hereafter may come under the jurisdiction of the State Conservation Commission, located within the following areas, are established and designated as the Council Grounds State Roadside Park:

Township 31 North, Range 6 East, Lincoln County

Section 8 - Govt. Lot 1

South 400 feet of the NE 1/4 NW 1/4

Section 9 - Govt. Lots 1, 2, 3, 4 and 5


Section 10 - Govt. Lot 6

The rules, amendments and repeals contained herein shall take effect on December 1, 1965.
