History: Chapter A-V 2 as it existed on January 31, 1967 was repealed and a new chapter A-V 2 was created effective February 1, 1967.

A-V 2.01 Policies for vocational and adult education classes. (1) VOCATIONAL OBJECTIVE. The term "vocational objective" as stated in section 41.21 (1) (b) 1, Wis. Stats., means systematic, organized instruction for which a person enrolls with the purpose of preparing for employment or preparation for home and family living, improving for employment, or courses which will contribute to the development of civic and/or economic proficiency. This includes all courses of a vocational nature and civic and general education courses which meet the conditions of state aid described below, but does not include those courses or programs which qualify for state aid as state-wide full time post high school programs under section 41.21 (1) (b) 3.

(2) **STUDENT PERIOD OF ATTENDANCE.** An aidable period of attendance shall consist of at least 50 minutes of continuous instruction. Multiple periods shall be computed at the basic amount.

A-V 2.02 Conditions of state aid. (1) PAYMENT OF STATE AID. State aid will be paid only to schools conducting classes which have been designated and approved by the state board.

(2) **CRITERIA FOR APPROVAL.** Each class, institute, workshop, project or service which is considered for state aid, shall be evaluated on the basis of the following criteria:

(a) *Teachers.* Classes must be taught by competent persons meeting certification requirements of the state board of vocational, technical and adult education where applicable. When teachers are not governed by certification requirements there must be on file in the state office a record describing experience and training which indicates competence in the field of instruction.

(b) *Enrollment.* State aid will be reimbursed upon attendance of students in accordance with provisions of state law.

(c) *Course, outlines or plans.* Course outlines or plans must be on file and available for review in the local school. Classes which continue from year to year and meet all other requirements may have outlines approved on a five year basis. Classes must be offered for at least 6 periods subject to federal aid policy interpretation, and must carry titles or subtitles which appropriately describe the course.

(d) *Special considerations for state aid. 1. Courses.* Courses must have an educational objective. Courses which are social or recreational, sports and games, activities for amusement and/or entertain-

ment, project production or courses which have limited educational objectives are not eligible for state aid.
