IN THE MATTER OF AMENDING CHAPTER MVD * ORDER ADOPTING AMENDMENTS AS PROVIDED
17.20(4), AND MVD 17.40(4)(em) OF THE * IN CHAPTER 227, WIS. STATS.
WISCONSIN ADMINISTRATIVE CODE *

Pursuant to authority vested in me as Administrator of the Division of Motor Vehicles of the Department of Transportation of the State of Wisconsin, under Sections 110.06 and 40.53 (7), Wis. Stats., amendments to MVD 17.20(4), and MVD 17.40(4)(em), of the Wisconsin Administrative Code were published in the Notice section of the Wisconsin Administrative Register in accordance with 227.02 (1)(e), Wis. Stats., as set forth in full infra;


I find that the statutory 30 days under the aforesaid subsection of the statute has expired; and, no petition for public hearing on this proposal has been made by 25 persons affected by the amendments, or a municipality which will be affected by the amendments, or an association which is representative of a farm, labor, business or professional group which will be affected by such amendments.

THEREFORE, IT IS HEREBY ORDERED, That the following amendments are hereby adopted to read:

17.20(4) Brakes. Bus chassis manufactured prior to January 1, 1968 shall be governed by the applicable provisions of Chapter MVD 5, Wisconsin Administrative Code, in effect when the vehicle was manufactured. The following provisions for brakes shall become effective January 1, 1968 on bus chassis manufactured after that date. Until that date the requirements of section MVD 5.23, Wisconsin Administrative Code 1963 edition shall be in effect.

17.40(4)(em) For buses originally manufactured as school buses prior to January 1, 1968, the brake requirements ~~(4)(a)~~ through ~~(e)~~ apply until January 1, 1968, of Chapter MVD 5, Wisconsin Administrative Code in force at the time of manufacture shall apply. After that date the following requirements shall apply: The following provisions shall apply to buses originally manufactured as school buses after January 1, 1968.
