ORDER OF THE DEPARTMENT OF AGRICULTURE  
AMENDING RULES

Pursuant to authority vested in the Department of Agriculture by sections 93.07 (1) and 227.02 (1) (b), the Department of Agriculture hereby amends rules as follows:

1. Section Ag 1.03 of the Wisconsin administrative code is amended by substituting "secretary" for "director" in the second and sixth lines.

2. Section Ag 1.05 of the Wisconsin administrative code is amended by substituting "secretary" for "director" in the first line.

3. Section Ag 1.07 of the Wisconsin administrative code is amended by substituting "secretary" for "director" in the second line.

4. Section Ag 2.01 (1) of the Wisconsin administrative code is amended by substituting "secretary" for "director" in the fourth line.

5. Section Ag 2.01 (2) of the Wisconsin administrative code is amended by substituting "secretary" for "director" in the first, fourth and fifth lines.

6. Section Ag 2.01 (3) of the Wisconsin administrative code is amended by striking "Director, State Department of Agriculture, State Capitol, Madison, Wisconsin" in the second and third lines and substituting therefor "Secretary of Agriculture, Hill Farms State Office Building, 4802 Sheboygan Avenue, Madison, Wisconsin 53702", and by substituting "secretary" for "director" in

the fourth and eighth lines.

7. Section Ag 2.01 (4) of the Wisconsin administrative code is amended by substituting "secretary" for "director" in the second line.

8. Section Ag 10.10 (1) of the Wisconsin administrative code is amended by substituting "secretary" for "director" in the seventh line.

The amendments of rules contained herein shall take effect January 1, 1968.
