OF THE EDUCATIONAL APPROVAL COUNCIL  
ADOPTING RULES

Pursuant to authority vested in the Educational Approval Council by section 39.021(3) and pursuant to the provisions of section 227.02(1)(b), Wisconsin Statutes, the Educational Approval Council hereby rennumbers chapters HEA 2 and 3 of the Administrative Code, Rules of the Higher Educational Aids Board to chapters EAC 1 and 2, Rules of the Educational Approval Council, rennumbers references to chapter HEA 3 and to Wis. Adm. Code, sections HEA 2.04 and 2.02 appearing in sections HEA 2.01, 2.03 and 3.05(4) to references to chapter EAC 2 and to Wis. Adm. Code sections EAC 1.04 and 1.02 respectively, and amends such rules by substituting the initials "EAC" for the initials "HEA", the word "council" for the word "board", the word "council's" for the word "board's", the words "Educational Approval" for the words "Higher Educational Aids", and the statutory reference "39.021" for the statutory reference "15.98" wherever the initials "HEA", the word "board", the word "board's", the words "Higher Educational Aids" or the statutory reference "15.98" appear in chapters HEA 2 or 3 of the Administrative Code, Rules of the Higher Educational Aids Board. The above renumbering and amendments are adopted solely to bring the above rules into conformity with the Wisconsin Statutes as renumbered and amended by Chapter 214, Laws of 1967, which became effective on December 9, 1967, subsequent to the adoption of chapters HEA 2 and 3 of the Administrative Code, Rules of the Higher Educational Aids Board, and will be effective March 1, 1968.
