ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

ADOPTING, AMENDING AND REPEALING RULES

PURSUANT to authority vested in the State of Wisconsin Natural Resources Board by sections 23.09, 23.11 and 27.01, Wis. State., and Chapter 75, Laws of 1967, the State of Wisconsin Natural Resources Board hereby amends rules as follows:

SECTION 1. WCD 41.15 of the Wisconsin Administrative Code is created to read:

WCD 41.15 Hartman Creek State Park Recreation Area. All state-owned lands now or that hereafter may come under the jurisdiction of the State Conservation Commission, located within the following areas, are established and designated as Hartman Creek State Park Recreation Area:

SECTION 2. WCD 41.16 of the Wisconsin Administrative Code is created to read:

WCD 41.16 Lizard Mound State Park. All state-owned lands now or that hereafter may come under the jurisdiction of the State Conservation Commission, located within the following areas, are established and designated as Lizard Mound State Park:

Section 31 - That part of the E 1/2 NE 1/4 described as follows: Commencing at the NE corner of Section 31, T12N, R20E, thence west 75'; thence south 1,320'; thence west 225'; thence south 1,320'; thence east 300'; thence north 2,640' to p.o.b.	11.45
Section 32 - That part of the W 1/2 NW 1/4 described as follows: Commencing at the NW corner of Section 32, T12N, R20E, thence east 125'; thence south 1,610'; thence east 542'; thence south 25'; thence east 200'; thence south 1,030'; thence west 792'; thence north 2,640' to the p.o.b.	<u>22.64</u>
