Pursuant to authority vested in it by Sections 348.26 and 348.27, Wisconsin Statutes, the Commission hereby amends portions of Chapter Hy 30, Wis. Admin. Code, as follows:

Section 30.01(3)(a)1

1. Applications shall be made to the issuing authority on forms prescribed by the State of Wisconsin, Department of Transportation, Division of Highways, hereinafter known as the Division of Highways, which will be furnished to the applicant upon request.

Pursuant to authority vested in it by Sections 348.26 and 348.27, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.01(3)(e)9 as follows:

Section 30.01(3)(e)9

Transporting vehicle or vehicles under a permit shall be registered as required by Wisconsin Statutes, and any operational permits required by the State of Wisconsin Department of Transportation, Division of Motor Vehicles, Public Service Commission, or other agencies having jurisdiction shall be obtained. Wisconsin registration may be waived for vehicles registered in another state where such registration meets the requirements of the State of Wisconsin Department of Transportation, Division of Motor Vehicles.

Pursuant to authority vested in the Commission by Section 348.26 and 348.27, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.01(3)(e) by adding subsection 17 as follows:

Section 30.01(3)(e)17

17. Effective July 1, 1968, a permit will be issued for a vehicle and load exceeding an over-all length of 125 feet only when the transporting equipment includes a steerable and steered rear support or dolly. Effective January 1, 1969 a permit will be issued for a vehicle and load exceeding an over-all length of 100 feet only when the transporting equipment includes a steerable and steered rear support or dolly.

Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.02(1)(a) as follows:

Section Hy 30.02(1)(a)

Application to the Division of Highways, for special permits for transport over state trunk highways may be made by mail, in person, or by prepaid telegram, or teletype message. Applications by telegram or teletype shall be in the form required by the Commission and shall contain all required information. All applications by telegram or teletype shall be submitted to the main office of the Division of Highways at Madison, and will not be accepted by the Division of Highways district offices. The Commission may establish limits on the size and weight of loads for which applications may be made by telegram or teletype.

Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.02(1)(b) as follows:

Section 30.02(1)(b)

Applications by telephone shall be submitted only to the Division of Highways' main office at Madison, and will be accepted only in case of dire emergency which affects essential public services and not as a matter of convenience to the applicant, consignor or consignee to minimize or eliminate delay in delivery of the vehicle or load.

Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.02(2)(a) as follows:

Section 30.02(2)(a)

The Chief Traffic Engineer or his authorized representatives or any District Engineer or his authorized representatives may issue special permits subject to such size and weight and other limitations as the Commission may from time to time prescribe.

Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.02(2)(b) as follows:

Section 30.02(2)(b)

The Chief Traffic Engineer or his authorized representatives in the Division of Highways' main office at Madison may issue special permits for mobile homes pursuant to Section 348.26(4), Wisconsin Statutes, subject to such size and weight limits as the Commission, may from time to time, prescribe.

Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.02(3)(a) as follows:

Section 30.02(3)(a)

Special permits for the transportation of mobile homes shall not be issued by local authorities or by the Division of Highways' district offices.

Pursuant to authority vested in the Commission by Section 348.25 and 348.27(2), Wisconsin Statutes, the Commission hereby amends Chapter Hy. 30.02(5) Introductory Paragraph as follows:

Section 30.02(5) Introductory Paragraph

General Conditions. Special permits are issued subject to the general conditions set forth in Wisconsin Administrative Code Subsection Hy 30.01(3)(e) 1, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21 and 22 and the following:

- - Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, - the Commission hereby amends Chapter Hy 30.02(5)(d) as follows:

Section 30.02(5)(d)

A special permit issued by the Division of Highways for a movement which is partly on the state highway system and partly on other classes of highways, is valid only on State highways.

Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.02(5)(e) as follows:

Section 30.02(5)(e)

The following conditions relating only to special permits issued by the Chief Traffic Engineer or his authorized representatives in the main office of the Division of Highways for over-size mobile home combinations shall take precedence over any conflicting conditions set forth elsewhere in this statement of policy:

- Permits for mobile homes are valid for any class of highway, i.e., State, County, Town, Village or City;
- 2. Permits for mobile homes are valid only from sunrise to sunset, and are not valid Saturdays, Sundays, and Holidays.

Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.02(5)(f) as follows:

Section 30.02(5)(f)

Permits do not authorize the operation of more than 2 vehicles in combination except that an earth-mover may be transported with its power unit resting upon the bed of a semi-trailer and its single rear axle trailing on the roadway behind the semi-trailer, in which case the gross weight of the rear axle of the earth-mover shall not exceed 35,000 pounds. Such transporting of carry-all scrapers is prohibited over the interstate highways, including any partially completed sections, and also U.S. Highway 41 from Green Bay to Milwaukee.

Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.03(1)(a) as follows:

Section 30.03(1)(a)

Information to be Required on Application. The application shall be directed to the authority designated in the Statutes to grant such special permit, and shall state that application is made pursuant to Section 348.26(2), (3) and (4), Wisconsin Statutes, for a permit for a single trip to transport an article which cannot reasonably be divided and which exceeds the statutory size or weight limitations, or both, or for a load consisting of more than one article exceeding statutory size limitations when the statutory gross weight limitations are not exceeded, and the additional articles do not cause the vehicle and load to exceed statutory size limits in any way in which such limits would not be exceeded by a single article. The form shall provide space for the applicant to indicate the vehicle

type, make, capacity, number of axles, license number, (if no license number, then the_serial_number) State of registration, empty-and loaded weight of both the towingand towed vehicles. The form shall provide space for the listing of the article or articles to be transported, the number and weight of such articles and the total weight of vehicle and load. The form shall provide space for indicating the width, height and length of the towing vehicle, towed vehicle, load and combined vehicle and load, as well as space for indicating whether the application is made for a vehicle or combination of vehicles or load exceeding statutory width, height, length, weight or other limitations. The form shall provide space for the applicant to indicate the number of tires, and gross load on each axle, the spacings between axles, and the total gross weight of vehicle(s) and load. The form shall provide space for the applicant to indicate the highways to be used and the origin and terminus of both the loaded trip and the return (or unloaded) trip, the number of miles travelled on each trip, the anticipated date of movement, the number of hours the load will be on the road, the name and address of the owner of the load, the name and address of the applicant's insurance company, and the number and expiration date of the insurance policy. The form shall specify that the applicant certifies that to the best of his knowledge and belief the statements contained in the application are true and correct, that he has read and understands the conditions which are a part of the application, that he will have the required insurance in effect while transporting under a permit, and that if granted a permit he will comply with all terms and conditions which apply to the movement. The form shall provide space for the signature and address of the applicant and for the date of the application.

Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.03(1)(b) as follows:

Section 30.03(1)(b)

Application for special permit by telegram or teletype. The Commission designates the following described form as acceptable for use in applying for a special permit by telegram or teletype:

The application shall be directed to the Division of Highways at its main office in Madison, Wisconsin, shall provide space for the applicant to describe the load, the origin and terminus of the trip, the highways to be used, the make, type, license number, (if no license number, then the serial number) and dimensions of the towing and towed vehicles, and the number of axles on each. The form shall also provide space for the overall dimensions of vehicle and load, the gross weight on each axle, the axle spacing, the name and address of the owner of the load and of the permittee's insurance company, the number of hours the load will be on the road, the total miles to be travelled, the proposed date of movement, the place to which the permit is to be sent, and the name and address of the applicant.

Pursuant to authority vested in it by Section 348.26, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.03(2) as follows:

Section 30.03(2)

Where to Obtain Form. This form is obtainable from the Division of Highways, State Office Building, Madison, Wisconsin 53702, and from its district offices throughout the state. It is also generally obtainable from the offices of the Pursuant to authority vested in it by Section 348.27, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.04(1)(a) as follows:

Section 30.04(1)(a)

Annual permit applications shall be directed to the Chief Traffic Engineer, Division of Highways, Madison, Wisconsin 53702.

Pursuant to authority vested in it by Section 348.27, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.04(2) as follows:

Section 30.04(2)

Authorization to issue annual permits. The Chief Traffic Engineer or his authorized representatives may issue annual permits subject to such size, weight and other limitations as the Commission may, from time to time, prescribe.

Pursuant to authority vested in it by Section 348.27, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.04(4)(a) as follows:

Section 30.04(4)(a) intro part.

The permittee shall present evidence on a form furnished by the Division of Highways that at least the following insurance coverage, or in lieu thereof a bond in a form satisfactory to the Division of Highways is or will be in full force and effect on the vehicle and load designated in the permit while operating on the public highway, except when insurance requirements are specifically waived by the Commission.

Pursuant to authority vested in it by Section 348.27, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.04(4)(b) as follows:

Section 30.04(4)(b)

The permittee shall furnish casualty insurance of an approved type or a bond or deposit a certified check with the Division of Highways in the amount indicated above determined by the Commission as necessary to protect the State and its subdivisions against any damage which any highway, highway structure, or its appurtenances may sustain by reason of operation under the permit.

Section 30.04(5)(g)

Annual permits do not authorize the operation of more than 2 vehicles in combination except that an earth-mover may be transported with its power unit resting upon the bed of a semi-trailer and its single rear axle trailing on the roadway behind the semi-trailer, in which case the gross weight of the rear axle of the earth-mover shall not exceed 35,000 pounds. Such transporting of carry-all scrapers is prohibited over interstate highways, and U.S. Highway 41 from Green Bay to Milwaukee. Pursuant to authority vested in it by Section 348.27, Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.05(1)(a) as follows:

Section 30.05(1)(a)

Information to be Required on Application. The application shall be submitted in duplicate, shall be directed to the Division of Highways and shall state that the application is made for an annual permit for the transporting of vehicles or articles of such a size or weight, or both, as to require a permit under Section 348.27(2), Wisconsin Statutes. The form shall provide space for the applicant to indicate the make, manufacturer's serial number, license number, state and year of registration, length, width, height, empty weight, manufacturer's rated gross weight and type of vehicle; the number of tires, and gross weight loaded for each axle of the vehicle, the distance between axles and the distance between the front axle and king pin (if truck-tractor) or between king pin and nearest axle (if semi-trailer) or between nearest adjacent axles of tractor and trailer (if full trailer), the over-all length, width, and height and total weight of vehicle and largest load applicant desires to haul. The form shall also provide space for the applicant to state the kinds of equipment or material which would usually be hauled on the vehicle. The form shall specify that the applicant understands that any annual permit granted will be subject to the conditions which are a part of the application and that he accepts those conditions. The form shall provide space for the name and address of the applicant and the date of application, and for the applicant to indicate whether the requested permit is for a single article which exceeds statutory size, but not weight limitations; or a vehicle and load consisting of a single article which exceeds statutory size or weight limitations or both; or a load consisting of more than one article some or all of which exceeds statutory size but not weight limitations; or a single article which exceeds statutory size or weight limitations or both, or alternately one or more articles some or all of which exceed statutory size but not weight limitations.

Pursuant to authority vested in it by Section 348.27(5), Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.13(1)(a) as follows:

Section 30.13(1)(a)

Information to be Required on Application. The application shall be submitted in duplicate, shall be directed to the Division of Highways, and shall state that the application is made for a vehicle transportation permit for a vehicle combination specifically constructed for transporting motor vehicles as provided in Section 348.27(5), Wisconsin Statutes. The form shall provide space for the applicant to indicate the make, manufacturer's serial number, license number, state and year of registration, type of vehicle, length of vehicle, when empty and loaded, maximum number of motor vehicles carried on the permitted vehicle, the name and address of his insurance company and the number and expiration date of his insurance policy. The form shall also specify that the applicant understands that any vehicle transportation permit granted will be subject to the conditions which are a part of the application and that he accepts those conditions. The form shall provide space for the name and address of the applicant and the date of the application,

Pursuant to authority vested in it by Section 348.27(6), Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.14(1)(a) as follows:

Section 30.14(1)(a)

Applications for trailer-train permits for movement over state trunk highways shall be directed to the Chief Traffic Engineer, Division of Highways, Madison, Wisconsin 53702.

Pursuant to authority vested in it by Section 348.27(6), Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.14(2)(b) as follows:

Section 30.14(2)(b)

The Chief Traffic Engineer or his authorized representatives may issue trailer-train permits for movement on the State Trunk Highway System, subject to such size and other limitations as the Commission may, from time to time, prescribe.

Pursuant to authority vested in it by Section 348.27(6), Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.14(2)(c) as follows:

Section 30.14(2)(c)

Trailer-train permits issued by local authorities for transportation over highways outside of the corporate limits of cities and villages shall not be valid until approved by the Commission or its authorized representatives. Section 30.16(2)

Authorization to Issue Mobile Home Annual Permits. The Chief Traffic Engineer or his authorized representatives may issue mobile home annual permits subject to such size and other limitations as the Commission may, from time to time, prescribe.

Pursuant to authority vested in it by Section 348.27(7), Wisconsin Statutes the Commission hereby amends Chapter Hy 30.16(4)(a) Introductory Paragraph as follows:

Section 30.16(4)(a) Introductory Paragraph

The permittee shall present evidence on a form furnished by the Division of Highways that at least the following insurance coverage, or in lieu thereof, a bond in a form satisfactory to the Division of Highways is or will be in full force and effect on the vehicle and load designated in the permit while operating on the public highway, except when insurance requirements are specifically waived by the Commission.

Pursuant to authority vested in it by Section 348.27(7), Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.16(4)(b) as follows:

Section 30.16(4)(b)

Pursuant to authority vested in it by Section 348.27(7), Wisconsin Statutes, the Commission hereby amends Chapter Hy 30.17(1)(a) as follows:

Section 30.17(1)(a)

Information to be Required on Application. The application shall be submitted in duplicate, shall be directed to the Division of Highways, and shall state that the application is made for an annual permit for a towing vehicle used in the transportation of oversize mobile homes over any of the highways of the state pursuant to Section 348.27(7), Wisconsin Statutes. The form shall provide a space for the applicant to indicate the make, license number, manufacturer's serial number and state of registration of the towing vehicle, serial number for any vehicle for which there is no license number or for which there is no individual license number unique to that vehicle as is the case with dealers and transporters and manufacturers licenses, the length, width, and height of the towing vehicle, mobile home and combination of towing vehicle and mobile home, a certification that the towing vehicle shall be a truck of not less than one and one-half tons manufacturer's rated capacity equipped with dual wheels on the drive axle, and that the applicant is a licensed mobile home manufacturer, dealer, or transport company, and the license number issued to the dealer, or transport company, and the license number issued to the company and the issuing agencies. The form shall also specify that the applicant understands that any mobile home annual permit granted will be subject to the conditions that are a part of the application and that he accepts those conditions. The form shall provide space for the name and address of the applicant and the date of application, and for the manufacturer's rated gross vehicle weight.
