ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

ADOPTING, AMENDING, REPEALING AND CREATING RULES

Pursuant to the authority vested in the Secretary of the State of Wisconsin Natural Resources Board by sections 23.09, 23.11, 27.01 and 28.02, Wis. Stats., the State of Wisconsin Natural Resources Board hereby adopts, amends, repeals and creates rules as follows:

SECTION 1. WCD 45.01 (3)(j) of the Wisconsin Administrative Code is amended to read:

WCD 45.01 (3)(j) A parent or parents with their children and not more than 2 lineal relatives or not more than 2 minor guests.

SECTION 2. WCD 45.04 (1) of the Wisconsin Administrative Code is amended to read:

WCD 45.04 (1) It shall be unlawful to wash vehicles or pets, except at authorized locations, in any state park, state park recreation area, fish hatchery and improved campsite in any state forest or at any similar public use area on other lands and property under the management, supervision and control of the commission.

SECTION 3. WCD 45.05 (1) of the Wisconsin Administrative Code is amended to read:

WCD 45.05 (1) It shall be unlawful for any person to suffer his dog or cat to enter any public building or be upon any bathing beach or designated swimming area in any state park, state forest, fish hatchery, state park recreation area or similar public use area on other lands and property under the management, supervision and control of the commission. In those state park areas where pets are permitted, and in campgrounds, picnic areas, headquarters areas and ranger stations on state forests or other properties under the management, supervision and control of the commission, dogs shall at all times be kept on a leash not more than 8 feet long. All others shall be effectively restrained or under the owner's control at all times. No person shall suffer his pet to deprive or disrupt the enjoyment or use of any area by others.

SECTION 4. WCD 45.06 (1) of the Wisconsin Administrative Code is amended to read:

WCD 45.06 (1) It shall be unlawful for any person to start, tend or maintain any fire or to burn any refuse except at designated fireplaces in any state park, state park recreation area, improved campsite in any state forest, fish hatchery or the State Experimental Game and Fur Farm. The aforementioned is also unlawful when fireplaces are provided at other campsites, picnic grounds and other designated similar public use areas on state forest lands or other lands under the management, supervision and control of the state conservation commission of Wisconsin.

SECTION 5. WCD 45.08 (2) of the Wisconsin Administrative Code is amended to read:

WCD 45.08 (2) It shall be unlawful to operate or park any motor vehicle except for motor driven sleds, toboggans, or other snowmobiles upon any bridle path, hinking trail, beach area, playground, picnic area, golf course (except golf carts on golf courses) or any area other than established roads, parking areas, boat ramps and service areas, or contrary to posted notice.

SECTION 6. WCD 45.08 (3) of the Wisconsin Administrative Code is amended to read:

WCD 45.08 (3) It shall be unlawful for any person to operate a motor vehicle except for motor driven sleds, toboggans, or other snowmobiles on state-owned lands in Rock Island State Park or in the Apostle Islands State Forest.

SECTION 7. WCD 45.09 (1)(t) of the Wisconsin Adminstrative Code is created to read:

WCD 45.09 (1)(t) On the waters of Birch Lake, Section 4, T6N, R5E, town of Brigham, Iowa county, Wisconsin.

WCD 45.13 (2) Camping is prohibited except in designated areas in state parks, state park recreation areas, state forests, Meadow Valley Wildlife Area and Yellowstone Wildlife Area. shall be unlawful to camp in such areas without a permit and payment of the prescribed fees except when:

SECTION 9. WCD 45.13 (3)(a) of the Wisconsin Administrative Code is amended to read:

WCD 45.13 (3)(a) Payment of camping fees, other than for group camps, is waived on-the-American-Legion,-Black-River,-Brule-River, Flambeau-River-and-Northern-Highland-State-Forests between October 31 and the following April 1.

SECTION 10. WCD 45.13 (3)(b) of the Wisconsin Administrative Code is amended to read:

WCD 45.13 (3)(b) Payment of camping fees is waived on the Elroy-Sparta State Trail, the Tuscobia-Park Falls State Trail, the Trempealeau Mountain Campground in Perrot State Park, Meadow Valley Wildlife Area and at trail campsites in the Kettle Moraine State Forest.

SECTION 11. WCD 45.13 (4) of the Wisconsin Administrative Code is amended to read:

WCD 45.13 (4) In all state parks, state recreation areas, Kettle Moraine, and Point Beach State Forests, Crystal-Muskie Campground in the Northern Highland State Forest and Yellowstone Wildlife Area a camping permit must be obtained prior to setting up camp during the period between June 15 and Labor Day unless otherwise posted and until December 1 in Meadow Valley Wildlife Area unless otherwise posted.

SECTION 12. WCD 45.14 (2) of the Wisconsin Administrative Code is repealed.

SECTION 13. WCD 45.14 (5) of the Wisconsin Administrative Code is amended to read:

WCD 45.14 (5) No person shall have in possession any firearm unless the same is unloaded and enclosed in a carrying case while within the exterior boundary of any state-owned wildlife area in Kenosha, Ozaukee, Racine, Walworth, Washington and Waukesha Counties or on state forest lands in the Kettle Moraine or the Point Beach State Forests except while engaged in hunting or while dog training or at a target range.

SECTION 14. WCD 45.15 of the Wisconsin Administrative Code is renumbered WCD 45.15 (1), and WCD 45.15 (2) of the Wisconsin Administrative Code is created to read:

WCD 45.15 (2) It shall be unlawful for any person to drink or possess any intoxicating liquor or fermented malt beverage in any state park, or Kettle Moraine and Point Beach State Forests between March 31 and June 16.

SECTION 15. WCD 45.17 (2)(f) 2 and 3 of the Wisconsin Administrative Code are repealed.

SECTION 16. WCD 45.17 (2)(f) 15 of the Wisconsin Administrative Code is created to read:

WCD 45.17 (2)(f) 15. Crystal-Muskie campground

SECTION 17. WCD 45.19 (1) of the Wisconsin Administrative Code is amended to read:

WCD 45.19 (1) It shall be unlawful for any person to carry or consume any food or beverages of any kind on any bathing beach or in the water adjacent to any bathing beach in any state park, state park recreation area, the-Kettle-Moraine-State-Forest-and Point-Beach-State-Forest and state forest, except in designated areas.

SECTION 18. WCD 45.19 (2) of the Wisconsin Administrative Code is amended to read:

WCD 45.19 (2) It shall be unlawful to swim beyond or disturb or molest a bathing beach boundary buoy or marker in any swimming beach in any state park, state park recreation area, and the-Kettle Moraine-and-Point-Beach-Forests state forest.

SECTION 19. WCD 45.19 (3) of the Wisconsin Administrative Code is amended to read:

WCD 45.19 (3) No floating device of any kind is permitted in or upon the water in the swimming area at any supervised beach in any state park, state park recreation area, and the-Kettle-Moraine and-Point-Beach state forests forest.

The rules, amendments and repeals contained herein shall take effect on May 1, 1969.
