ORDER OF THE DEPARTMENT OF ADMINISTRATION

ADOPTING RULES

Pursuant to authority vested in the Department of Administration by sections 16.84 (1) and (11), and 16.93, Wis. Stats., the Secretary of the Department of Administration hereby adopts rules as follows:

Section Adm 1.01 of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

Adm 1.01 Police officers. Such persons as shall be authorized by the department of administration shall be constituted security officers and shall have the power to enforce these rules and regulations, and for the purposes thereof shall police all property under the control of the department of administration. Such officers shall have all the powers provided in sections 16.84 (2) and 16.93 (2), Wis. Stats.

Section Adm 1.02 (1) and (2) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

Adm 1.02 Designation of state office buildings. The following buildings are hereby designated as state office buildings for the purposes of parking regulation under these rules.

(1) Category 1 - Parking regulated under section 16.93 (1), Wis. Stats:

State Capitol Park and such portions of the curb on the Capitol Park side of the 4 surrounding streets as are designated in section 16.93 (1), Wis. Stats.

(2) Category 2 - Parking regulated under section 16.93 (2), Wis. Stats.

Section Adm 1.05 (3) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

(3) Parking shall be restricted at Category 1 locations
(see section Adm 1.02 above) as provided in section 16.93 (3),
Wis. Stats.

Section Adm 1.06 of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

Adm 1.06 Penalties. The penalties for violating these
rules and regulations are those set forth in section 16.93 (2),
Wis. Stats.

The rules contained herein shall take effect on February 1, 1970, as provided
in section 227.026 (1), Wis. Stats.
