ORDER OF THE HIGHWAY COMMISSION AMENDING RULES

Pursuant to authority vested in it by Subsection 349.08(1), 40.60(3), 349.11(5) and 349.16(2), Wisconsin Statutes, the Highway Commission hereby amends and adopts rules as follows:

Section Hy. 11.01(2) is amended to read:

(2) Permissive Interim Standards. Stop signs which comply with Chapter Hy. 11 as published in the Wisconsin Administrative Register for January, 1956, may be used before October 1, 1970, but after September 30, 1970, all Stop signs and their installation and use shall comply with these rules.

Section Hy. 12.01(2) is amended to read:

(2) Permissive Interim Standards. Signs which comply with Chapter Hy. 12 as published in the Wisconsin Administrative Register for October, 1966, may be used before October 1, 1970, but after September 30, 1970, all signs covered by these rules and their installation and use shall comply with these rules. All new sign installations made after January 1, 1967, shall comply with these rules.

Section Hy. 13.01(2) is amended to read:

(2) Permissive Interim Standards. Signs which comply with Chapter Hy. 13, as published in the Wisconsin Administrative Register for January, 1956, and as amended in the Wisconsin Administrative Register for July, 1956, may be used before October 1, 1970, but after September 30, 1970, all Speed Limit signs and their installation and use shall comply with these rules.

Section Hy. 14.01(2) is amended to read:

(2) Permissive Interim Standards. Signs which comply with Chapter Hy. 14 as published in the Wisconsin Administrative Register for January, 1956, may be used before October 1, 1970, but after September 30, 1970 all signs covered by these rules shall comply with these rules.

Section Hy. 18.01(2) is amended to read:

(2) Permissive Interim Standards. Yield signs which comply with Chapter Hy. 18 as published in the Wisconsin Administrative Register for January, 1960, may be used before October 1, 1970, but after September 30, 1970, all Yield signs and their installation and use shall comply with these rules.

Section Hy. 21.02 is amended to read:

Hy. 21.02 Effective date of regulations. All traffic signal installations made after January 1, 1963, shall comply with these rules. Installations made prior to January 1, 1963, shall comply with Chapter Hy. 15 as published in the Wisconsin Administrative Register for January, 1956, or with these rules. After September 30, 1970, all installations on all highways shall comply with these rules.

Section Hy. 22.02 is amended to read:

Hy. 22.02 Effective date of regulations. All installations of flashing traffic control signals made after January 1, 1963, shall comply with these rules.

Installations made prior to January 1, 1963, shall comply with Chapter Hy. 15 as published in the Wisconsin Administrative Register for January, 1956, or with these rules. After September 30, 1970, all installations on all highways shall comply with these rules.
