ORDER ADOPTING RULES

ORDER OF THE LAW ENFORCEMENT STANDARDS BOARD

ADOPTING, AMENDING OR REPEALING RULES

Pursuant to authority vested in the Law Enforcement Standards Board by section 165.85 Wis. Stats., the Law Enforcement Standards Board hereby amends its administrative rules as follows:

Section LES 5.01 (2) of the WISCONSIN ADMINISTRATIVE CODE is amended by adding the following sentence to section 5.01 (2):

The Board however, may, upon submission and approval of expense vouchers for trainees successfully completing a certified program, authorize immediate disbursement to a participating agency in an amount of up to 60% of the approved claim.
