ORDER OF THE DEPARTMENT OF NATURAL RESOURCES ADOPTING, AMENDING OR REPEALING RULES

Pursuant to authority vested in the Department of Natural Resources by 227.02 (2)(b), Wis. Stats., the Department of Natural Resources hereby repeals, amends and adopts rules as follows:

Chapter WCD 5 of the Wisconsin Administrative Code is renumbered and amended as follows:

CHAPTER WGD NR 5

- SECTION 1. Chapter WCD 5 is renumbered to Chapter NR 5.
- SECTION 2. WCD 5.01 is renumbered to NR 5.01.
- SECTION 3. WCD 5.02 is renumbered to NR 5.02 and amended to read:

WGD NR 5.02 Application for transfer. An application for a transfer certificate of number in addition to furnishing the information required by WGD NR 5.01 shall include a statement by the applicant listing the name and address of the previous owner, his certificate number, and the date on which the boat was acquired by the applicant. The applicant shall also sign the statement.

SECTION 4. WCD 5.03 is renumbered to NR 5.03 and amended to read:

WGD NR 5.03 Application for duplicate. An applicant for a duplicate certificate of number in addition to furnishing the information required by section WGD NR 5.01 shall complete and sign a statement that the original certificate has been either destroyed or lost and that the application being made is for a duplicate.

- SECTION 5. WCD 5.04 is renumbered to NR 5.04.
- SECTION 6. WCD 5.05 is renumbered to NR 5.05.
- SECTION 7. WCD 5.06 is renumbered to NR 5.06.
- SECTION 8. NR 5.06 (1) is amended to read:
- (1) The assigned number shall be painted on, or attached, to each side of the bow of the boat for which it was issued. The numbers shall be placed in

such position as to provide clear legibility for identification. The numbers shall read from left to right and shall be in block characters of good proportion not less than 3 inches in height and shall be spaced as provided in section WGD NR 5.05 (2). The numbers shall be of a color which will contrast with the color of the background and so maintained as to be clearly visible and legible; i. e., dark numbers on a light background, or light numbers on a dark background.

SECTION 9. WCD 5.07 is renumbered to NR 5.07 and amended to read:

WGD NR 5.07 Transfer of ownership of numbered boat. Whenever the owner of a boat covered by a valid or expired certificate of number issued by this state transfers all or any part of his interest in such boat, other than by the creation of a security interest, he shall notify the commission department of such transfer within 15 days.

SECTION 10. WCD 5.08 is renumbered to NR 5.08.

SECTION 11. WGD NR 5.08 (intro. par.) is amended to read:

WGD NR 5.08 Accident report. Written reports of boating accidents required by section 30.67, Wis. Stats., shall be addressed to Wisconsin Genservation Department; of Natural Resources, Box 450, Madison, Wisconsin 53701, and shall supply the following information:

SECTION 12. WCD 5.09 is renumbered to NR 5.09.

SECTION 13. WGD NR 5.09 (3) (c) (intro. par.) is amended to read:

(c) The agency or political subdivision of the state authorizing the placement of a waterway marker will inform the commission department of the following:

SECTION 14. WCD 5.10 is renumbered to NR 5.10.

SECTION 15. WCD 5.11 is renumbered to NR 5.11.

SECTION 16. WCD 5.12 is renumbered to NR 5.12.

The rules, amendments, and repeals contained herein shall take effect on publication.
