ORDER NO. 78

IN THE MATTER of prescribing Rules and Regulations, pursuant to authority contained in Section 215.02(12)(a), Wis. Stats., for conducting the business of savings and loan associations operating under Chapter 215, Wis. Stats.

WHEREAS, this matter was initially approved by the Deputy Commissioner of Savings and Loan and the Savings and Loan Review Board on March 25, 1971, under the procedure prescribed in Section 227.02(1)(e), Wis. Stats., and
