ORDER OF THE DEPARTMENT OF NATURAL RESOURCES
ADOPTING, AMENDING OR REPEALING RULES

Pursuant to authority vested in the Department of Natural Resources by 227.02 (2) (b), Wis. Stats., the Department of Natural Resources hereby repeals, amends and adopts rules as follows:

SECTION 1. Chapter RD 14 is renumbered to Chapter NR 114.

SECTION 2. RD 14.01 is renumbered to NR 114.01.

SECTION 3. RD 14.02 is renumbered to NR 114.02.

SECTION 4. RD 14.03 is renumbered to NR 114.03.

SECTION 5. RD 14.04 is renumbered to NR 114.04.

SECTION 6. RD 14.05 is renumbered to NR 114.05.

SECTION 7. RD 14.06 is renumbered to NR 114.06.

SECTION 8. RD 14.07 is renumbered to NR 114.07.

SECTION 9. RD 14.08 is renumbered to NR 114.08.

SECTION 10. RD 14.09 is renumbered to NR 114.09.

SECTION 11. RD 14.10 is renumbered to NR 114.10.

SECTION 12. RD 14.11 is renumbered to NR 114.11.

SECTION 13. RD 14.12 is renumbered to NR 114.12.

SECTION 14. NR 114.12 (1) is amended to read:

(1) Sewage Treatment Plant Operators. Individuals holding a valid grade I certificate may operate class I, II, III and IV sewage treatment plants. Individuals holding a valid grade II certificate may operate class II, III and IV sewage treatment plants. Individuals holding a valid grade III certificate may operate class III and IV sewage treatment plants. Individuals holding a valid grade IV certificate may operate class IV sewage treatment plants. Individuals holding a grade V certificate may operate class V waste treatment facilities in accordance with Wis. Adm. Code Section ~~RD-14.07~~ NR 114.07 (7).

SECTION 15. RD 14.13 is renumbered to NR 114.13.


