## ORDER OF THE DEPARTMENT OF NATURAL RESOURCES ADOPTING, AMENDING OR REPEALING RULES

Pursuant to authority vested in the Department of Natural Resources by 227.02 (2) (b), Wis. Stats., the Department of Natural Resources hereby repeals, amends and adopts rules as follows:

SECTION 1. NR 115.02 (1) is amended to read:

(1) The water resources act creates section 59.971, Wis. Stats., which requires the zoning of shorelands in the unincorporated areas of each county. Such zoning shall not require the approval of the town boards. To assure that such zoning will be accomplished, section 59.971 (6), Wis. Stats., states that if any county does not adopt an ordinance by January 1, 1968, or if the department ef-natural-resources, after notice and hearing, determines that a county had adopted an ordinance which fails to meet reasonable minimum standards in accomplishing the shoreland protection objectives, the department shall adopt such an ordinance.

SECTION 2. NR 115.03 (2) (intro. par.) and (3) (a) are amended to read:

(2) ESTABLISHMENT OF LAND USE ZONING REGULATIONS. The zoning provisions adopted must provide sufficient control of the use of shorelands to afford the protection of water quality as specified in Wis. Adm. Code chapters RD-2-and-3 NR 102 and 103. The provisions shall include the following:

(3) (a) Where public water supply systems are not available, private well construction shall conform to Wis. Adm. Code chapter RD-12 NR 112.

The rules, amendments and repeals contained herein shall take effect on publication.
