ORDER OF THE DEPARTMENT OF NATURAL RESOURCES ADOPTING, AMENDING OR REPEALING RULES

Pursuant to authority vested in the Department of Natural Resources by 227.02 (2) (b), Wis. Stats., the Department of Natural Resources hereby repeals, amends and adopts rules as follows:

- SECTION 1. Chapter WCD 23 is renumbered to Chapter NR 23.
- SECTION 2. WCD 23.01 is renumbered to NR 23.01.
- SECTION 3. WCD 23.02 is renumbered to NR 23.02.
- SECTION 4. WCD 23.03 is renumbered to NR. 23.03.
- SECTION 5. WCD 23.04 is renumbered to NR 23.04.
- SECTION 6. WCD 23.05 is renumbered to NR 23.05.
- SECTION 7. WCD 23.06 is renumbered to NR 23.06.
- SECTION 8. WCD 23.07 is renumbered to NR 23.07.
- SECTION 9. NR 23.07 (2) is amended to read:
- (2) FISH SHANTIES. Buildings, vehicles, tents, fish shanties or similar enclosures may be used on the ice for fishing purposes in the waters specified in this chapter. The door of any such enclosure of shelter shall be equipped with a latch which will permit the door to be readily opened from the outside at all times while enclosure or shelter is occupied. All such shelters shall be removed from the ice on or before the close of the ice fishing season each year on all waters listed in this chapter, or previous to that time by the order of the eenservation-commission department or by its agents when they feel that the ice has become unsafe for travel thereon.
 - SECTION 10. WCD 23.08 is renumbered to NR 23.08.
 - SECTION 11. NR 23.08 is amended to read:
- WGD NR 23.08 RECIPROCITY. All residents of Wisconsin and Michigan holding a resident fishing license from their respective states, or residents of states other than Wisconsin and Michigan holding an angling license issued by either

state, may fish in any of the waters listed in section WGD NR 23.01. This reciprocity applies only to hook and line fishing and the taking of minnows for such fishing, but minnows so taken shall not be sold, traded or bartered.

The rules, amendments, and repeals contained herein shall take effect on publication.
