ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD AMENDING RULES

Pursuant to authority vested in the State of Wisconsin Natural Resources Board by sections 23.09, 28.02, 28.03, 28.035 and 227.02, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby amends rules as follows:

SECTION 1. Chapter NR 40.07 of the Wisconsin Administrative Code is amended to read as follows:

NR 40.07 ST. CROIX RIVER STATE FOREST. All state-owned lands now or that hereafter may come under the jurisdiction of the department within the boundaries hereinafter described are hereby created, established and designated as the St. Croix River state forest.

- (1) Beginning at the northwest corner of section 25, T41N, R17W, Burnett County;
- (2) thence east on section line to the quarter corner between sections 24 and 25, T41N, R17W;
 - (3) thence south to the south quarter corner of section 36, T41N, R17W;
- (4) thence west along the township line between townships 40 and 41 north to the northeast corner of section 3, T41N, R17W;
- (5) thence south on section line to the southeast corner of section 10, T40N, R17W;

- (6) thence west on section line to the southeast corner of section 7, T40N, R17W;
- (7) thence south on section line to the southeast corner of section 18, T40N, R17W;
- (8) thence west on section line to point on south line of section 18, T40N, R17W, where County Trunk F turns southwest;
- (9) thence southwest on County Trunk F to south line of section 24, T40N, R18W;
- (10) thence west on section line to southeast corner of section 23, T40N, R18W;
- (11) thence south on section line to the southeast corner of section 26, T40N, R18W;
- (12) thence west on section line to the southeast corner of section 25, T40N, R19W;
- (13) thence south on range line between ranges 18 and 19, to the southeast corner of section 36, T40N, R19W;
- (14) thence west on township line between townships 39 and 40, to the northeast corner of section 2, T39N, R19W;
- (15) thence south on section line to the quarter corner between sections 1 and 2, T39N, R19W;
 - (16) thence west to the center of section 2, T39N, R19W;
- (17) thence south to the quarter corner between sections 2 and 11, T39N, R19W;
- (18) thence west on section line to the northeast corner of NWNE, section 10, T39N, R19W;
- (19) thence south along east line of NWNE, SWNE, NWSE, and SWSE, to the southeast corner of SWSE, section 10, T39N, R19W;

- (20) thence west on section line to the quarter corner between sections 10 and 15, T39N, R19W;
- (21) thence south to the quarter corner between sections 15 and 22, T39N, R19W;
- (22) thence west on section line to the quarter corner between sections 16 and 21, T39N, R19W;
- (23) thence south to the quarter corner between sections 28 and 33, T39N, R19W;
- (24) thence west on section line to the quarter corner between sections 29 and 32, T39N, R19W;
- (25) thence south to the quarter corner between secions 17 and 20, T38N, R19W;
- (26) thence west on section line to the quarter corner between sections 18 and 19, T38N, R19W;
- (27) thence south to the quarter corner between sections 19 and 30, T38N, R19W;
 - (28) thence west to the northeast corner of NWNW, section 30, T38N, R19W;
- (29) thence south along east line of NWNW, SWNW, NWSW and SWSW, to the southeast corner of SWSW, section 30, T38N, R19W;
- (30) thence west on section line to the point on north line of section 36, T38N, R20W, where River Road turns southwest;
- (31) thence southwest along River Road to the intersection of River Road and the south line of section 3, T37N, R2OW;
- (32) thence west on section line to the southeast corner of section 5, T37N, R20W;
- (33) thence south on section line to the southeast corner of section 29, T36N, R2OW;

- (34) thence east on section line to the southwest corner of section 30, T36N, R19W;
- (35) thence north on range line to the northwest corner of section 19, T36N, R19W;
- (36) thence east on section line to the northeast corner of section 19, T36N, R19W;
- (37) thence south on section line to the northwest corner of section 32, T36N, R19W;
- (38) thence east on section line to the northeast corner of section 32, 136N, R19W;
- (39) thence south on section line to the southeast corner of section 32, T36N, R19W;
- (40) thence east on township line to the north quarter corner of section 4, T35N, R19W;
 - (41) thence south to the south quarter corner of section 4, T35N, R19W;
 - (42) thence west on section line to the east shore of the St. Croix River;
- (43) thence north along the east shore of the St. Croix River to the north-west corner of section 25, T41N, R17W, being the place of beginning.
 - (44) All lying in Burnett and Polk Counties, Wisconsin.

The rules, amendments and renumbering contained herein shall take effect upon publication.
