ORDER OF

DEPARTMENT OF INDUSTRY, LABOR AND HUMAN RELATIONS

Pursuant to authority vested in the Department of Industry, Labor and Human Relations by section 101.01 to 101.29, Wis. Stats., the Department of Industry, Labor and Human Relations hereby renumbers, creates and adopts the rule; of Wisconsin Administrative Code Chapter 1, Safety.

The rules attached hereto shall become effective on the first day of the month following publication in the Wisconsin Administrative Code as provided in Section 227. Section Ind 1.01 Scope to be renumbered Ind 1.001 Scope.

Section Ind 1.02 Definitions to be renumbered Ind 1.01 Definitions.

Section Ind 1.03 Standards and specifications to be renumbered Ind 1.02 Standards and specifications.

Section Ind 1.03 is created to read:

Ind 1.03 Inspections. (1) The authorized inspectors of the Department, upon presenting appropriate credentials to the owner, operator, or agent in charge, is authorized--

- (a) to enter without delay and at reasonable times any factory, plant, establishment, construction site, or other area, workplace or _environment where work is performed by an employee of an employer; and
- (b) to inspect and investigate during regular working hours and at other reasonable times, and within reasonable limits and in a reasonable manner, any such place of employment and all pertinent conditions, structures, machines, apparatus, devices, equipment, and materials therein, and to question privately any such employer, owner, operator, agent or employee.
- (2) The inspector before making his inspection shall contact a representative of the employer and a representative authorized by his employees who shall be given an opportunity to accompany the inspector during the physical inspection of any workplace under (1) for the purpose of aiding such inspection.
 - (a) Where there is no authorized employee representative, the inspector shall consult with a reasonable number of employees concerning matters of health and safety in the workplace.

NOTE: The above rules are based on portions of Section 8, Public Law 91-596, "Occupational Safety and Health Act of 1970."
