

ORDER OF THE
PUBLIC SERVICE COMMISSION
AMENDING RULES

Pursuant to authority vested in the Public Service Commission by Chapters 195 and 196 and section 227.08, Wis. Stats., the Public Service Commission hereby amends rules as follows:

Sections PSC 2.04, PSC 2.30(2), and PSC 2.36(1) of the WISCONSIN ADMINISTRATIVE CODE are amended to read:

PSC 2.04 Furnishing copies of records. (1) One certified copy of the decision in a proceeding will be furnished free of charge at the time of issuance to each party of record, except that when a party of record is represented by counsel, a copy of the decision will be furnished to said counsel. When a municipal utility is a party of record to a proceeding, a copy of the decision will be furnished both to the management of the utility and to the appropriate official of the municipality free of charge at the time of issuance.

(2) General orders will be distributed free of charge at the time of issuance under the supervision of the secretary.

(3) Except for copies distributed free of charge as enumerated in subsections (1) and (2) of this section and in Wis. Adm. Code section PSC 2.36(1), copies of transcripts, orders, or other records of the commission may be obtained upon payment, in advance, of applicable rates determined by the commission.

PSC 2.30(2) A motor transportation calendar will be issued each week containing applications scheduled for hearing, grants of authority without hearing, full or partial assignments of authority approved without hearing, and changes in previously scheduled hearings. The weekly motor carrier calendar will be sent by first class mail to each person applying therefor, upon payment for a calendar year, or on a proportionate quarterly basis, of the charge determined by the commission and based primarily on postage rates. The motor transportation calendar will be mailed



PSC 2.36 Transcripts. (1) Proceedings in hearings will be transcribed and one copy of the transcript will be furnished each party free of charge upon request by such party on the record at the hearing. Additional copies of transcripts will be furnished upon request, and upon payment of charges in advance as provided for in Wis. Adm. Code section PSC 2.04(3).

The amendments contained herein shall take effect on January 1, 1972 as provided in section 227.026(1)(Intro. par.), Wis. Stats.

NOTICE IS HEREBY GIVEN That pursuant to chapters 195 and 196 and section 227.08, Wis. Stats., and according to the procedure set forth in section 227.02 (1)(e), Wis. Stats., the Public Service Commission will amend the following rules as herein proposed without public hearing thereon unless, within 30 days after the publication of this notice, November 1, 1971, it is petitioned for a public hearing on said rules, amended as proposed, by 25 persons who will be affected by the rules, a municipality which will be affected by the rules, or an association which is representative of a farm, labor, business or professional group which will be affected by the rules:

Sections PSC 2.04, PSC 2.30 (2), and PSC 2.36 (1) are amended to read as follows:

PSC 2.04 Furnishing copies of records. (1) One certified copy of the decision in a proceeding will be furnished free of charge at the time of issuance to each party of record, except that when a party of record is represented by counsel, a copy of the decision will be furnished to said counsel. When a municipal utility is a party of record to a proceeding, a copy of the decision will be furnished both to the management of the utility and to the appropriate official of the municipality free of charge at the time of issuance.

(2) General orders will be distributed free of charge at the time of issuance under the supervision of the secretary.

NOTICE IS HEREBY GIVEN That pursuant to section 41.04 (2)(e), Wis. Stats., and according to the procedure set forth in section 227.02 (1)(e), Wis. Stats., the Wisconsin Retirement Fund Board will adopt the following rule without public hearing thereon unless, within 30 days after publication of this notice, November 1, 1971, it is petitioned for a public hearing on said proposed rule by 25 persons who will be affected by the rule, a municipality which will be affected by the rule, or an association which is representative of a farm, labor, business or professional group which will be affected by the rule.

RET 4.60 is created to read:

RET 4.60 In lieu of a retirement annuity in the normal form any participant may elect to receive the actuarial equivalent thereof as a life annuity terminating at the end of the month prior to the month in which the annuitant dies, with no death benefit to be paid thereafter. An annuity payable pursuant to this subsection shall be computed by the actuary, and certified to the board, on the basis of the mortality and interest rates underlying table E-Life as set forth in RET 4.011.


