ORDER OF THE STATE OF WISCONSIN BOARD OF NURSING
AMENDING OR REPEALING RULES

Pursuant to authority vested in the State of Wisconsin Board of Nursing by section 441.01 (3) Wis. Stats., the Board hereby creates Section N7.03 (9) attached hereto and repeals Section N7.04 (1) through (8) Wisconsin Administrative Code.

The adoption and repeal contained herein shall take effect as provided in Section 227.026 (1) Wis. Stats.



The Wisconsin Administrative Register, November 1971, No. 191, Nursing, contained an announcement that the State of Wisconsin Board of Nursing would create Section N7.03 (9) Restriction and would repeal Section N7.04 (1) through (8) Legislative Scholarships without public hearing. After receipt of fifty-one signatures requesting a hearing, notice was placed in the Wisconsin Administrative Register, February 1972, No. 194, Nursing, of a hearing scheduled for March 28, 1972 at 10:00 A.M. This hearing was held and the Board of Nursing, after a review of the transcript, took affirmative action on May 17, 1972 as follows to:

Create - Section N7.03 Board of Nursing (9) Restriction. The recipient of a Board of Nursing scholarship shall not accept any other scholarship monies covering the same period of time. Under unusual circumstances the board may permit the acceptance and use of monies from several sources provided it has given prior approval. A recipient who violates this provision shall be expected to refund all board scholarship funds, previously received, within 90 days of the demand notice from the secretary.

Repeal - N7.04 (1) through (8) Legislative scholarships for nursing educators.
