ORDER OF THE BOARD OF VETERANS AFFAIRS AMENDING RULES

Pursuant to authority vested in the Board of Veterans Affairs of the Department of Veterans Affairs by Section 45.35(3) and pursuant to Chapter 227, Wis. Stats., the Board of Veterans Affairs hereby amends sections VA 2.01(2) and VA 3.04(intro.) of the Wisconsin Administrative Code, Rules of the Department of Veterans Affairs, to read as follows:

VA 2.01(2) is amended to read:

VA 2.01(2) SCOPE OF EMERGENCY AID. Emergency aid to prevent want or distress may be authorized to provide essential medical care, dental care, glasses, shelter, food, clothing, health insurance, travel, moving expenses, department or other professional counseling services for returning Vietnam era veterans in areas of employment, educational or related opportunities, including employment by the department in a limited-term status of such returning Vietnam era veterans on an emergency-aid basis to enhance their educational or employment opportunities, and such incidentals as may be deemed necessary. Emergency aid for a student will be construed as assistance that will enable him to successfully pursue his education.

VA 3.04(intro.) is amended to read:

VA 3.04 SECURITY. Security or quarantors acceptable to the department will be required on all loans in excess of \$250 \$350. Furniture will not be taken as security on loans for business purposes or for the payment of debts.
