



IN THE MATTER of prescribing Rules and Regulations, pursuant to authority contained in Section 215.02(12)(a), Wis. Stats., for conducting the business of Savings and Loan Associations operating under Chapter 215, Wis. Stats.

WHEREAS, this matter was initially approved by the Savings and Loan Commissioner and the Savings and Loan Review Board on July 19, 1972, under the procedure prescribed in Section 227.02(1)(e), Wis. Stats., and

WHEREAS, official notice of the proposed changes was published in the Wisconsin Administrative Register, August 1972, No. 200, pursuant to the requirements of Section 227.02(1)(e), Wis. Stats., and

WHEREAS, no petition for a public hearing on the proposed changes was filed during the 30 day period subsequent to the publication of the official notice of the proposed changes in the Wisconsin Administrative Register,

August 1972, No. 200, and

WHEREAS, the proposed changes were finally approved by the Savings and Loan Commissioner and the Savings and Loan Review Board on October 9, 1972.

NOW, THEREFORE, IT IS ORDERED:

Section S-L 23.01(1) is amended to read:

S-L 23.01 Mobile home financing. (1) AUTHORIZATION. Any association, upon adoption of a mobile home financing plan by its board of directors, may under the permissive authority contained in Sec. 215.205(1), Wis. Stats., invest in loans on mobile homes, chattel paper or interests, therein, evidencing financing of mobile homes, subject to the following limitations:

IT IS FURTHER ORDERED, that Order No. 83 shall become a part of the Rules of the Commissioner of Savings and Loan, Wisconsin Administrative Code, effective the first day of the month following publication thereof in the Wisconsin Administrative Register for November 1972, No. 203.
