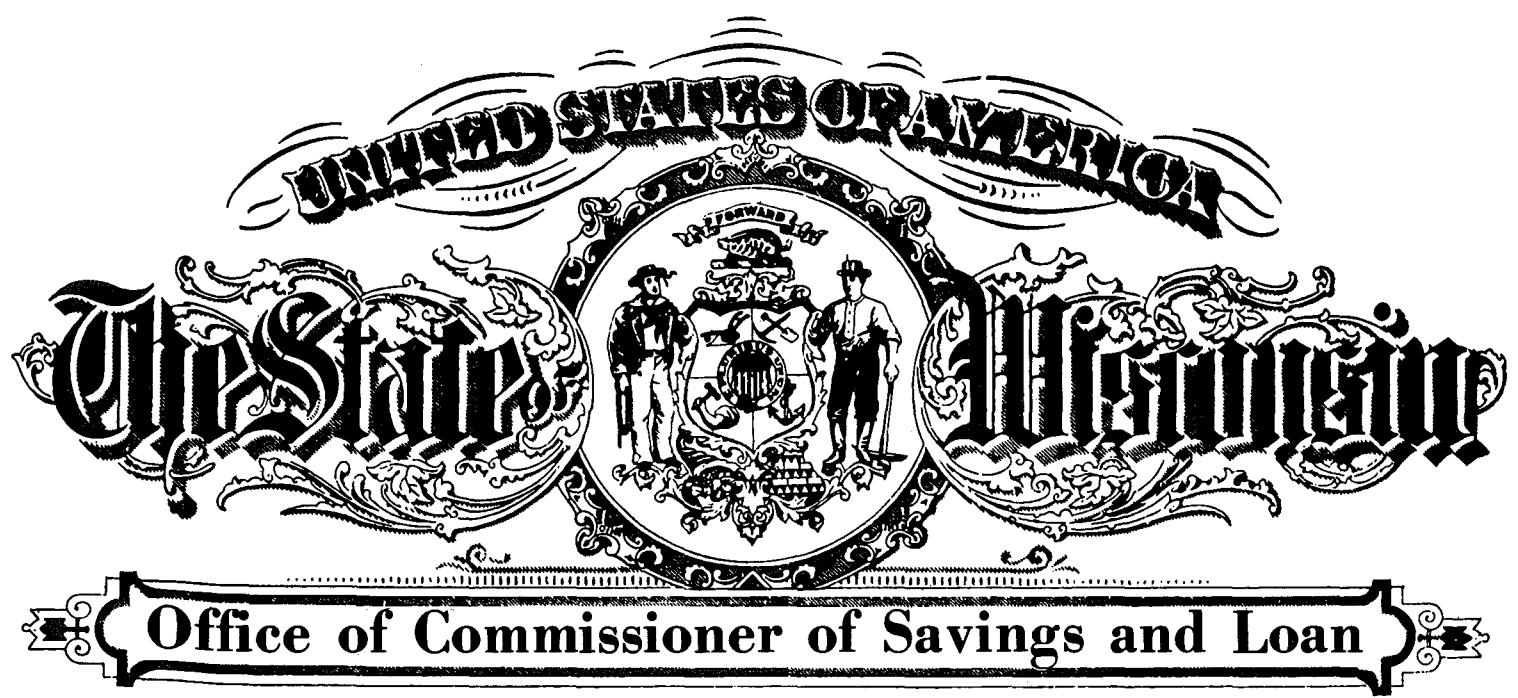

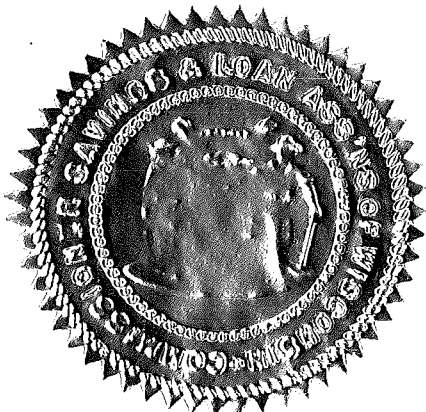

IN THE MATTER of prescribing Rules and Regulations pursuant to authority contained in Section 215.02(12)(a), Wis. Stats., for conducting the business of savings and loan associations operating under Chapter 215, Wis. Stats.

IT IS FURTHER ORDERED, That Order No. 86 shall become a part of the Rules of the Commissioner of Savings and Loan, Wisconsin Administrative Code, effective the first day of the month following publication thereof in the Wisconsin Administrative Register for February 1974, No. 218.
