ORDER OF THE LAW ENFORCEMENT STANDARDS BOARD

ADOPTING, ADMENDING, OR REPEALING RULES

Pursuant to authority vested in the Law Enforcement Standards Board by sections 165.85 Wis. Stats., the Law Enforcement Standards Board hereby repeals, amends, and adopts as follows:

Section LES 5.01 (1) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

LES 5.01 (1) Political subdivisions shall be eligible for grants of reimbursement in an amount <u>of</u> 100% of the salary, and the allowable tuition, living and travel expenses incurred by law enforcement officers taking the preparatory course <u>and not less than 60%</u> <u>nor more than 75% of the allowable tuition, living</u> <u>and travel expenses incurred by law enforcement officers</u> <u>completing additional training up to 320 hours</u> for the purpose of complying with the Board's training standards for permanent appointment, when the political subdivision concerned meets the following conditions:

LES 5.01 (1)(c) Completion of forms to be obtained from the Bureau covering documentation of the compliance with Board-established recruitment and training standards, and AutHokized including a formal claim for reimbursement of Atraining expenses, Actually IncuRRED.
