ORDER OF THE  
PUBLIC SERVICE COMMISSION  
CREATING A RULE

Pursuant to authority vested in the Public Service Commission by chapters 195, 196, and 227, Wis. Stats., the Public Service Commission creates an emergency rule as follows:

Section PSC 2.01 (4) of the WISCONSIN ADMINISTRATIVE CODE is hereby created to read:

PSC 2.01 Communications and documents addressed to commission; meetings of commission, official notice.

(4) Pursuant to section 66.77, Wis. Stats., as repealed and recreated by chapter 297, Laws of 1973, relating to open meetings of governmental bodies, the public service commission hereby gives official notice as provided therein that it will hold an open commission meeting each weekday Monday through Friday at 10:00 a.m. or as soon thereafter on said day as a meeting can be held, in the commission meeting room, 433 Hill Farms State Office Building, to transact such business as may appear on the daily agenda for commission action on that specific day. Matters falling within section 66.77 (4), Wis. Stats., will be conducted at a meeting convened and held in closed session as provided therein. In the event that no matter arises which requires official determination, or in the absence of a quorum, no meeting will be convened. The existence of an agenda for the day

and the matters on it can be ascertained by calling the Main Office of the commission, Area Code 608, 266-1241 after 8:00 a.m., on the particular day involved, or by otherwise requesting said information.


The rule herein adopted shall take effect on June 17, 1974, as an emergency rule.

#### FINDING OF EMERGENCY

In order to be in immediate compliance with chapter 297, Laws of 1973, which would not otherwise be possible due to the time needed to comply with statutory notice, hearing, and publication requirements of chapter 227, Wis. Stats., the commission hereby adopts the above Wis. Adm. Code section PSC 2.01 (4) as an emergency rule to take effect upon the June 17, 1974 publication in the official state paper, and filing with the revisor of statutes and the secretary of state as provided in section 227.027, Wis. Stats.
