ORDER OF THE EXAMINING BOARD OF ARCHITECTS, PROFESSIONAL ENGINEERS, DESIGNERS AND LAND SURVEYORS ADOPTING AND AMENDING RULES

Pursuant to authority vested in the Examining Board of Architects, Professional Engineers, Designers and Land Surveyors by sections 15.08, 227.014, 443.01 and 443.02, Wis. Stats., the Examining Board of Architects, Professional Engineers, Designers and Land Surveyors hereby amends and adopts rules as follows:

Sections A-E 5.01(5)(e) and 5.01(6)(e) of the WISCONSIN ADMINISTRATIVE CODE are amended to read:

A-E 5.01(5)(e):

(e) The map shall identify the person for whom the survey was made, the date of the survey, and shall describe the parcel as provided in (4), above:

A-E 5.01 (6)(e):

(e) Bearings or angles on any property survey map shall be shown to the nearest minute; distances shall be shown to the nearest 1/100th foot.

Section A-E 4.08 of the WISCONSIN ADMINISTRATIVE CODE is adopted to read:

A-E 4.08. Suspension of license; effect. Any registrant whose license has been suspended is prohibited during the term of the suspension from engaging in any of the following activity:

- (1) Offering to perform any service which requires said license;
- (2) Performing any professional service which requires said license;
- (3) Signing or sealing plans, specifications, reports, maps, plats, or charts prepared for the practice of architecture. professional engineering, designing or land surveying;
- (4) Entering into contracts the performance of which requires said license;
- (5) Engaging in responsible supervision of construction as defined in section 443.01(2)(q), Wis. Stats;

The rules and amendments contained herein shall take effect on the first day of the month following their publication in the Wisconsin Administrative Register.
