#### ORDER REPEALING RULES

On March 10, 1975, the Public Service Commission issued a notice proposing the repeal of the rules set forth in the Wisconsin Administrative Code, Chapter PSC 50, "without public hearing thereon unless, within 30 days after publication of the notice, it is petitioned for a public hearing on the proposal by 25 persons who will be affected by repeal of the rules, a municipality which will be affected by repeal of the rules, or an association which is representative of a farm, labor, business or professional group which will be affected by repeal of the rules." (Section 227.02(1)(e), Wis. Stats.)

In compliance with section 227.018(2), Wis. Stats., the Commission by letters dated March 13, 1975, notified members of the Senate Standing Committee on Commerce, the Assembly Standing Committee on Transportation, and the Assembly Standing Committee on Highways of the aforesaid proposal to repeal rules as stated above. No notified standing committee of the legislature has directed the Public Service Commission to meet with it to review the draft of the proposed repeal of Wis. Adm. Code Chapter PSC 50.

On April 16, 1975, a petition bearing the signatures of 25 residents of the City of Lake Geneva was filed with the Commission. The petition requested that the matter be set for public hearing.

On April 17, 1975, the Commission issued a notice scheduling the matter for public hearing. Said notice was published in the Notice Section of the Wisconsin Administrative Register for April 1975.

Pursuant to due notice, hearing was held on May 13, 1975, in Lake Geneva, before Examiner Bryan J. Borman.

Findings of Fact

### THE COMMISSION FINDS:

Improvements in the State Trunk Highway system, together with a reduction in the number of trucks operating on weekends, permit present restrictions relating to the use of highways on weekends to be eliminated, except on segments of highways in the Lake Geneva area. The removal of such restrictions in the Lake Geneva area at this time would create a safety problem and cause financial hardship on the Lake Geneva community.

# Conclusions of Law

### THE COMMISSION CONCLUDES:

That it has authority under Chapter 194, Wis. Stats., to issue an order repealing parts of Wis. Adm. Code Chapter PSC 50.

### Order

# THE COMMISSION THEREFORE ORDERS:

- 1. That pursuant to authority vested in the Public Service Commission by Chapter 194, Wis. Stats., it hereby repeals Wis. Adm. Code section PSC 50.02(1),(3), (4), (9), and (12).
- 2. That a certified copy of the repeal of the subsections of section PSC 50.02, as listed in paragraph No. 1, above, be filed with the Secretary of State and the Revisor of Statutes as required by section 227.023, Wis. Stats.
- 3. That the repeal of the named subsections of Wis. Adm. Code section PSC 50.02 become effective on the first day of January, 1976.
