Pursuant to authority vested in me as Administrator of the Division of Motor Vehicles of the Wisconsin Department of Transportation under Section 110.06, 218.01 (5)(a) and (c), and Chapter 227, of the Wisconsin Statutes, the amendment to Chapter MVD 24 of the Wisconsin Administrative Code was published in the Notice section of the Wisconsin Administrative Register in accordance with 227.02 (1)(e), Wis. Stats., as set forth below;

I find, that the statutory 30 days under the aforesaid subsection of the statute has expired; and, no petition for public hearing on this proposal has been made by 25 persons affected by the amendment, a municipality which will be affected by the amendment, or an association which is representative of a farm, labor, business or professional group which will be affected by the amendment;

THEREFORE, IT IS HEREBY ORDERED, that Chapter MVD 24 of the Wisconsin Administrative Code, be amended and adopted as follows:

24.06 (2) is renumbered 24.05 (10):

24.05 (10) It is an unfair practice and prohibited for a warrantor to fail to service or repair a motor vehicle in accordance with the terms and conditions of the warranty or service agreement.

24.06 is repealed.

24.07 is renumbered 24.06 :

MVD 24.06 Waiver. Waiver of any requirement of chapter MVD 24, except as specifically provided for in chapter MVD 24 is prohibited and void.
