

## Chapter Med 5

TEMPORARY CAMP PHYSICIAN OR  
LOCUM TENENS LICENSE

**History:** Chapter Med 5 as it existed on April 30, 1976, was repealed and a new Chapter Med 5 was created effective May 1, 1976.

**Med 5.01 Authority and purpose.** The rules in this chapter are adopted by the medical examining board pursuant to the authority delegated by sections 15.08 (5) and 227.08, Wis. Stats., and govern the issuance of temporary camp physician or locum tenens licenses, as provided in section 448.03 (3), Wis. Stats.

**Med 5.02 Applications, credentials and eligibility.** An applicant physician who holds a valid license to practice medicine and surgery issued by another licensing jurisdiction of the United States may apply to the board for temporary license under this chapter, and shall submit to the board the following:

(1) A completed and verified application form supplied by the board for this purpose.

(2) A letter from a physician licensed to practice medicine and surgery in this state requesting the applicant's services, or a letter from a camp organization or other recreational facility of this state requesting the applicant's services.

(3) A verified photostatic copy of a license to practice medicine and surgery in another licensing jurisdiction of the United States. The application and documentary evidence submitted will be reviewed by 2 officers of the board, and upon the finding of such 2 officers of the board that a need exists for the applicant's services and that the applicant is qualified, the board, acting through such 2 officers, may issue a temporary license to practice medicine and surgery to such applicant.

**Med 5.03 Fee.** The fee for temporary license issued under this chapter must accompany the application therefor, and like fee paid for each renewal of such license.

**Med 5.04 Practice limitations.** The holder of a temporary license to practice medicine and surgery issued under this chapter may engage in the regular practice of medicine and surgery as provided in chapter 448, Wis. Stats., providing such practice is confined to the camp or recreational facility or geographical area for which the license is issued.

**Med 5.05 Expiration and renewal.** Temporary license to practice medicine and surgery issued under this chapter shall expire 90 days from the date of issuance. For cause shown to the satisfaction of 2 officers of the board, the board, acting through such 2 officers, may renew temporary license to practice medicine and surgery issued under this chapter for additional periods of 90 days each.
