Notice of proposed rule CSB 2.10 and 2.11 of the Wisconsin Administrative Code was published in the March, 1976, Wisconsin Administrative Register; that the Controlled Substances Board has received no notice, request or petition for a public hearing and the period for filing such request or petition has expired.

Therefore, pursuant to authority vested in the Controlled Substances Board by Section 161.11, Wis. Stats., the Controlled Substances Board hereby adopts the following rule:

(b) Fenfluramine

Paragraph (a) of subsec. (2m), sec. 161.20 Wis. Stats., Schedule IV is hereby created to read:


(a) Diethylpropion
