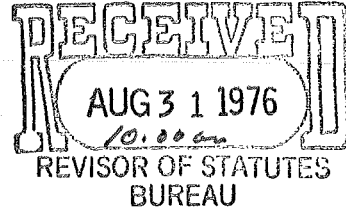

ORDER OF THE OFFICE OF THE COMMISSIONER OF INSURANCE
Amending Rules


