ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD
CREATING RULES

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 227.014(2), 227.02(1)(e) and 227.07, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby creates rules as follows:

SECTION 1 - Section NR 2.065 is created to read:

NR 2.065 Unless ordered by the examiner, all department contested case hearings are class 1 proceedings under section 227.01(2), Wis. Stats., except hearings held under sections 30.03, 144.025, 144.35, 144.537 and 144.91, Wis. Stats., and those hearings which modify, revoke or suspend a license as defined in section 227.01(3), Wis. Stats., issued by the department are class 2 proceedings.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on September 16, 1976.

The rules contained herein shall take effect upon publication.
