ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD REPEALING AND RECREATING RULES

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 23.09, 23.11, 29.174 and chapter 227, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby repeals and recreates rules as follows:

SECTION 1 - Section NR 10.05 (1) is repealed and recreated to read:

(1) While hunting it shall be unlawful except by permittees under section 29.09(9), Wis. Stats., to discharge any firearm or bow and arrow from or across any public road surfaced with concrete, blacktop or gravel or to hunt within 50 feet from the centerline of such roads or to the fenceline, whichever distance is shorter. Public roads are defined as those roads shown on the official county highway map.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on February 17, 1977.

The rules contained herein shall take effect upon publication.
