ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

CREATING RULES

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by section 147.04(1) and chapter 227, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby creates rules as follows:

Chapter NR 220

Categories and Classes of Point Sources

NR 220.01 Purpose. The purpose of this chapter is to establish pursuant to section 147.04(1), Wis. Stats., a list of categories and classes of point sources other than publicly owned treatment works for which effluent limitations, standards of performance, pretreatment standards, standards for toxic substances, and other standards have been or are to be established.
