ORDER OF THE DEPARTMENT OF REGULATION AND LICENSING AMENDING, REPEALING AND ADOPTING RULES

Pursuant to authority vested in the Department of Regulation and Licensing by Section 227.014(2), Wis. Stats., the Secretary hereby amends, repeals and adopts rules as follows:

Sections RL 3.01(7), RL 3.10(1)(a), RL 3.10(1)(b), RL 3.10(1)(c), RL 3.10 (2)(c), RL 3.12(1) (intro.), RL 3.12(2), and RL 3.13(4) of the Wisconsin Administrative Code are amended to read:

RL 3.01(7) "Private detective agency" or "Agency" means an individual, firm, association, company, partnership or corporation engaged in private detective work or employing persons engaged in private detective work, watchman and guard work, or both; or any individual, firm, association, company, partnership or corporation selling electronic alarm devices that employs uniformed individuals to monitor such devices.

RL 3.10(1)(a) At least 3 years' full-time employment as a private detective with a licensed agency; or

RL 3.10(1)(b) At least 3 years' full-time employment as a supervisor or administrator in industrial security or with a licensed agency; or

RL 3.10(1)(c) At least 3 years' full-time employment as a sworn member of any federal investigative agency, or as a sworn member of the military police or as a sworn member of any state, county, or municipal investigative agency or police department; or

RL 3.10(2)(c) Not have been convicted of a misdemeanor or ordinance violation relating to misappropriation, gambling, controlled substances or sexual morality or of crimes that substantially relate to the duties of security or investigative work within the three years prior to application.

RL 3.12(1) Examination. No person will be granted a private detective's license unless that person attains an average grade of 70% in the following subjects in an examination administered by the Department:

RL 3.12(2) An applicant who has passed the examination and remains unlicensed for one year or more shall again take and pass the examination before being licensed.

RL 3.13(4) Candidates will not be permitted to take the examination unless they submit a letter of admission issued by the department and a recent photo of reasonable likeness.

Section RL 3.11(2) is created and sections RL 3.40(2)(a) and RL 3.41(2)(c)

of the Wisconsin Administrative Code are repealed and recreated to read:

RL 3.11(2) Persons who are eligible for an exemption under s. 440.26(5) but who fail to obtain the required permit shall obtain a private detective license.

RL 3.40(2)(a) That person is a peace officer as defined in s. 939.22(22), Wis. Stats.; and

RL 3.41(2)(c) Proof that the principal or employee has met the minimum marksmanship standards set forth in the 1976 Wisconsin Law Enforcement Firearms Manual, published by the Training and Standards Bureau, Division of Law Enforcement Services, Wisconsin Department of Justice, State Capitol, Madison, Wisconsin 53702. The above-mentioned standard, which is hereby incorporated by reference, is available at the address above and at the offices of this department, the secretary of state and the revisor of statutes.

The rules, amendments, repeals and recreations contained herein shall take effect on October 1, 1977, pursuant to authority granted by section 277.026(1)(b), Wis. Stats.
