ORDER OF THE PHARMACY EXAMINING BOARD

ADOPTING, AMENDING OR REPEALING RULES

Pursuant to authority vested in the Pharmacy Examining Board by sections 15.08(5); 163.31 and 227.021 Wis. Stats., the Pharmacy Examining Board hereby repeals, amends, and adopts rules as follows:

Section Phar 1.08(5) of the WISCONSIN ADMINISTRATIVE CODE is repealed and recreated to read:

(5) Written or verbal copies of prescription orders for any prescription drug, given by a pharmacy from which the medication was dispensed pursuant to an original prescription order, shall be identified respectively in writing or verbally as "COPY—FOR INFORMATION ONLY". Such information copy has no legal status under federal or state law. The recipient pharmacist of such copy shall contact the prescribing practitioner for authorization to dispense the prescription, which is the same as obtaining an original prescription. The provider or transferor of such written or verbal copy shall invalidate the prescription order in its file as of the date the copy is given.

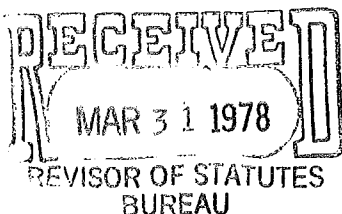
Section Phar 1.17 of the WISCONSIN ADMINISTRATIVE CODE is repealed.

Section Phar 1.18 of the WISCONSIN ADMINISTRATIVE CODE is repealed.

Sections Phar 3.04(3) and (4) of the WISCONSIN ADMINISTRATIVE CODE are amended to read:

(3) Applicants for reciprocal registration who have not been actively engaged in the practice of pharmacy as defined in Phar 1.19 for a minimum of 160 hours within the year preceding the submission of their application shall be required to show their proficiency in the compounding and dispensing of medication by passing a laboratory practical examination satisfactory to the examining board.

(4) Applicants for reciprocal registration shall be required to display their familiarity with the laws regulating the practice of pharmacy in Wisconsin by passing a written and oral examination satisfactory to the examining board on Wisconsin and federal laws and regulations governing the practice of pharmacy and a written or oral examination on the comprehensive practice of pharmacy.



Section Phar 6.02(4) of the WISCONSIN ADMINISTRATIVE CODE is adopted to read:

(4) Any pharmacy authorized to dispense controlled substances shall establish and maintain a prescription profile record system for all schedule II controlled substances dispensed for outpatient use. The required profile record shall be kept either as part of the pharmacy's uniformly maintained composite medication record system or as a separate profile record for schedule II controlled substances. The profile records shall be retained for 2 years and include at least the following information:

- (a) Patient identification
- (b) Drug allergies
- (c) Date prescription is dispensed
- (d) Prescription number
- (e) Prescribing practitioner
- (f) Drug product dispensed (dosage form and strength)
- (g) Daily dosage
- (h) Quantity of drug product dispensed

Computerized profile record systems and registered hospital patient records shall be deemed to comply with the requirements of this sub-section if they contain the information specified in paragraphs (a) - (h).


Effective date: Section Phar 6.02(4) takes effect on the first day of the 4th month commencing after its publication in the Wisconsin Administrative Register.

The rule contained herein as Section Phar 6.02(4) shall take effect on August 1, 1978 pursuant to authority granted by section 227.026(1)(b), Wis. Stats.

The rules, amendments, and repeals otherwise contained herein shall take effect on May 1, 1978 as provided in section 227.026(1), Wis. Stats.
