

ORDER OF THE STATE OF WISCONSIN DEPARTMENT OF AGRICULTURE, TRADE AND CONSUMER PROTECTION REPEALING AND ADOPTING RULES

Pursuant to authority vested in the State of Wisconsin Department of Agriculture, Trade and Consumer Protection by sections 93.07(1) and 93.09, Wis. Stats., the State of Wisconsin Department of Agriculture, Trade and Consumer Protection hereby repeals and adopts rules as follows:

- Section 1. Chapter Ag 119 of the Wis. Adm. Code is repealed.
- Section 2. Chapter Ag 84 of the Wis. Adm. Code is adopted to read:

CHAPTER AG 84 CHEESE STYLES, BOXES AND HOOPS

- Ag 84.01 <u>Definitions</u>. (1) "Department" means the state of Wisconsin department of agriculture, trade and consumer protection.
- (2) "Cheese" means cheddar, granular, colby, washed curd, Monterey (Jack) and Swiss cheese.
- (3) "Boxes" means wood, fiber, corrugated metal, or veneer containers used as receptacles for cheese.
- (4) "Diameter" means the diameter of the larger round end of cylindrical shaped cheese.
- (5) "Cheese hoops" means forms used to mold various styles of cheese described under section Ag 84.02.
- (6) "Scale board" means a flat piece of wood or veneer placed in the cheese box or container to protect the cheese from damage.

Ag 84.02 <u>Cheese styles; standards</u>. Cheese manufactured and sold under the following traditional styles shall conform to the size and weight standards for such styles as specified in the table below:

Ag 84.03 <u>Cheese hoops</u>. Cheese hoops shall be of such size and shape that the cheese molded therein will conform to size and weight standards for cheese styles as specified under section Ag 84.02.

Ag 84.04 New boxes. All boxes or containers for cheese shall be securely nailed or bound together and strong enough to carry the weight of the cheese they are designed to carry, and shall conform to the following requirements:

- (1) The dimensions of boxes or containers shall be sufficient to permit the easy entrance and removal of the cheese and thoroughly envelop and protect the cheese.
- (2) All boxes shall be clean and free of insects or other forms of contamination prior to sale or use.
- (3) Boxes manufactured from wood or veneer shall be constructed of commercially dry materials and contain not more than 18% moisture prior to sale or use as a receptacle for cheese.
 - (4) Scale boards shall not contain in excess of 18% moisture.
- (5) The name and address of the manufacturer shall be plainly stamped or impressed in type at least 1/4 inch high on the body of all boxes or containers manufactured for use as a receptacle or container for cheese.
- Ag 84.05 <u>Barrels</u>. Barrel cheese shall be marketed or transported in barrels free of liquids or excess moisture and covered with full removable covers which are securely jacketed and sealed.
- Ag 84.06 <u>Used boxes</u>. (1) All boxes that have been used as containers for cheese shall, before being reused in the marketing or transporting of cheese, be reconditioned as required and be cleaned so as to be free from adhering materials, objectionable odors or mold or other insanitary conditions.
- (2) Before the reuse of used boxes in the marketing or transporting of cheese, all marketings shall be completely obliterated or removed from the box except for markings used to designate the original manufacturer.
- (3) Used wood or veneer boxes shall meet the moisture requirements of new boxes at the time of reuse.

Ag 84.07 Other type boxes or containers. (1) The department may, on a temporary basis, authorize the experimental use of new types of boxes or containers deviating from requirements or standards as provided under this chapter to determine their feasibility in the containerization or shipment of cheese. If new type boxes or containers are found to be satisfactory, the department may authorize their continued or general use. Consent may be withdrawn if boxes or containers are found to be unsatisfactory.

(2) Shipping materials or containers conforming with standards adopted by the United States Department of Agriculture for the marketing and transporting of cheese shall meet the box or container requirements under this chapter.

Ag 84.08 <u>Authority; enforcement</u>. This chapter is adopted under authority of ss. 93.07(1) and 93.09, Stats. Any person violating this chapter may be punished as provided in s. 93.21, Stats.

The rules contained herein shall take effect as provided in s. 227.026, Stats.
