ORDER OF THE OPTOMETRY
EXAMINING BOARD ADOPTING,
AMENDING OR REPEALING RULES.

Pursuant to authority vested in the Optometry Examining Board by sections 15.08(5)(b) and 227.014(2)(a), Wis. Stats., the Optometry Examining Board hereby repeals, amends, and adopts rules as follows:

Section Opt 9.02 of the Wisconsin Administrative Code is amended to read:

Opt 9.02 Biennial requirement. Each licensed optometrist shall attend a minimum of 20 hours of continuing education courses. Satisfactory proof of compliance with this requirement is a prerequisite for registration under section 449.06 (1), Wis. Stats.

Section Opt 9.03(1) of the Wisconsin Administrative Code is amended to read:

Opt 9.03 Approved programs. (1) Only approved programs will receive credit toward compliance with the 20-hour requirement.

Section Opt 9.03(1)(c) of the Wisconsin Administrative Code is repealed.

Section Opt 9.04 of the Wisconsin Administrative Code is amended to read:

Opt 9.04 Proof of attendance. Satisfactory written proof of attendance at 20 hours of approved courses or programs shall be submitted with the registration application and fee.

The rules, amendments, and repeals contained herein shall take effect on the first day of the month following their publication in the Wisconsin administrative register as provided in sec. 227.026(1), Wis. Stats.
