Pursuant to the authority vested in the Veterinary Examining Board by-Sections 15.08(5) and 453.06, Wis. Stats., the Veterinary Examining Board repels, amends and adopts rules as follows:

Section VE 1.03 Definitions of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

(5) "Division of Consumer Complaints" is the division within the department of regulation and licensing established to perform investigative and prosecutorial functions at the direction of the Board.

Section VE 1.04 Institution of Proceedings of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

(3) Complaint of the division of consumer complaints based on its own investigation.

Section VE 2.02 of the WISCONSIN ADMINISTRATIVE CODE IS REPEALED.

Section VE 2.04 License; application of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

Application for license shall be made on forms prescribed by the Board and shall be accompanied by the examination fee. Should the applicant not take the next examination, after notification that the applicant has been accepted, applicant must reapply in order to qualify for the next examination.

Section VE 2.05 of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

License; fee, renewal, display thereof, change of address. (1) No license shall be renewed except upon payment of the biennial fee.

Section VE 2.05(2) of the WISCONSIN ADMINISTRATIVE CODE is adopted to read:

(2) The license and renewal shall be displayed in an area open to the public in the place of practice.

Section VE 2.05(3) of the WISCONSIN ADMINISTRATIVE CODE is adopted to read:

(3) Veterinarians shall notify the board of any change in their practice address within thirty days of such change.

Section VE 2.08(1)(c) of the WISCONSIN ADMINISTRATIVE CODE is repealed.

Section VE 3.01 Definitions of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

(9) "Variable services" include but are not limited to services on which the fee charged the client is based on the individual veterinarian's judgment, as to each individual patient's condition when presented to.

the veterinarian. Variable services are based upon the level and area(s) of expertise, advanced training, the professional time involved, and other factors related to the art of practice as the basis for that service. Variable services include surgery (with local and general anesthesia), diagnosis, prognosis, treatment and the prescription of medications.

Section VE 3.01 of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

"Non-variable services" include but are not limited to services for which the fee charged the client can be objectively determined without viewing the specific patient. Non-variable services include but are not limited to boarding of healthy animals, dehorning, collection of samples for testing, dispensing other than prescription legend animal drugs under FDA Reg. 21 CFR 1.106c and drugs listed in U.S. Controlled Substances Act of 1970 as amended.

Section VE 3.02 Unprofessional conduct of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

Unprofessional conduct. The following acts constitute unprofessional conduct by a veterinarian and are prohibited:

(8) The personal use, misuse, or sale, other than for medical treatment of animal patients, of the drugs listed in the U.S. Controlled Substances Act of 1970, as amended, or chapter 161, Wisconsin Statutes -1977. Not included are drugs prescribed by a physician for individual use by the veterinarian at any given time.

Section VE 3.02(12) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

(12) Failure to comply with any provision of chapter 95, Wis. Stats. 1977 or chapter Ag 10 of the Wisconsin Administrative Code, April of 1977.

Section VE 3.02(18) of the WISCONSIN ADMINISTRATIVE CODE is adopted to read:

(18) Practicing under an expired license.

The rules, amendments, and repeals contained herein shall take effect on September 1, 1978.
