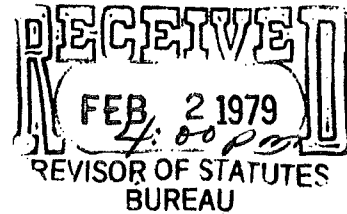

ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

REPEALING, AMENDING, REPEALING AND RECREATING, AND CREATING RULES

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 23.09, 23.11, 29.085, 29.174, 29.57 and 227.014, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby repeals, amends, repeals and recreates, and creates rules as follows:

SECTION 1 - Section NR 10.01 (2) (b) is repealed and recreated to read:

Kind of animal and locality	Open season (both dates inclusive)	Limits
(b) Sharp-tailed grouse		
1. All that part of Wisconsin lying northerly of a line beginning at the junction of state highway 64 and the west boundary of the state, then easterly along highway 64 to its junction with state highway 13, then southerly along highway 13 to its junction with state highway 29, then easterly along highway 29, ending in the city of Green Bay.	a. Beginning on the Saturday nearest October 15 and continuing for 23 consecutive days.	b. Daily bag 3; possession 6.
2. In all other parts of the state.	b. None	b. None

SECTION 2 - Section NR 10.01 (3) (a) is repealed and recreated to read:

Kind of animal and locality	Open season (both dates inclusive)	Limits
(a) Gray and fox squirrels		
1. In all counties of the state.	a. Beginning on the Saturday nearest September 15 and continuing through January 31.	b. Daily bag (total of both species) 5; possession 10.

SECTION 3 - Section NR 10.27 (1) is amended to read:

(1) Gun season only; Governor Dodge state park, Blue Mound state park and Perrot state park.

SECTION 4 - Section NR 11.27 (3) is repealed.

SECTION 5 - Section NR 15.01 (59) (f) is repealed.

SECTION 6 - Section NR 15.02 (79) is created to read:

(79) Sheboygan county. (a) Sheboygan Marsh wildlife area.

1. Township 16 north, range 20 east, town of Russell.

a. Section 20 - SESE

b. Section 21 - S $\frac{1}{2}$

c. Section 22 - S $\frac{1}{2}$

2. Township 16 north, range 20 east, town of Greenbush

a. Section 26 - W $\frac{1}{2}$

b. Section 27 - Entire section

c. Section 28 - E $\frac{1}{2}$ NW except E 200 feet of W 300 feet; NE; NESW except E 200 feet of W 300 feet; N $\frac{1}{2}$ SE and the SESE except E 200 feet of W 300 feet.

d. Section 29 - NENE

e. Section 33 - North 22.5 acres of NENE except E 200 feet of W 300 feet and N 200 feet of S 300 feet.

f. Section 34 - N $\frac{1}{2}$ N $\frac{1}{2}$ NW except N 200 feet of S 300 feet.

g. Section 35 - That part of the NW $\frac{1}{4}$ lying northeasterly from the old railroad R.O.W.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on November 15, 1978.

The rules contained herein shall take effect upon publication.
