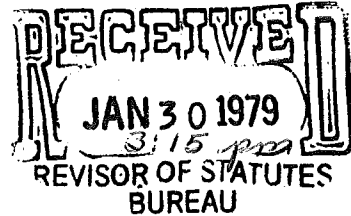

ORDER OF THE OPTOMETRY  
EXAMINING BOARD ADOPTING,  
AMENDING OR REPEALING RULES.

Pursuant to authority vested in the Optometry Examining Board by sections 15.08(5)(b), 227.014(2)(a) and 227.02, Wis. Stats., the Optometry Examining Board hereby repeals, amends, and adopts rules as follows:

Section Opt 1.01 of the Wisconsin Administrative Code is repealed.

Section Opt 2.02 of the Wisconsin Administrative Code is repealed.

Section Opt 2.03 of the Wisconsin Administrative Code is amended to read:

Opt 2.03 Delegates. The board may elect a delegate or delegates to the International Association of Boards and/or the National Board of Examiners in Optometry and, subject to the approval of the secretary of regulation and licensing, may pay such fees and expenses as are ordinary and necessary in the performance of duties as a delegate.

Section Opt 2.04 of the Wisconsin Administrative Code is amended to read:

Opt 2.04 Vice-chairman. In the event of the chairman's absence or incapacity, the vice-chairman shall exercise the powers of chairman with the approval of the other four board members.

Section Opt 2.05 of the Wisconsin Administrative Code is amended to read:

Opt 2.05 Membership in international association. The board may maintain an active paid membership in the International Association of Boards and the secretary shall submit vouchers for the annual dues thereof to the secretary of regulation and licensing for approval and payment.

Section Opt 2.06 of the Wisconsin Administrative Code is amended to read:

Opt 2.06 Vouchers. All vouchers for expenses, salaries, and per diem shall be signed by the chairman of the board except that any vouchers submitted on behalf of the chairman shall be signed by the vice-chairman.

Section Opt 3.01(3) of the Wisconsin Administrative Code is repealed.

Section Opt 3.01(4) of the Wisconsin Administrative Code is renumbered Opt 3.01(3).

Section Opt 3.02(2) of the Wisconsin Administrative Code is repealed.

Section Opt 4.10 of the Wisconsin Administrative Code is repealed.

Section Opt 6.04 of the Wisconsin Administrative Code is amended to read:

Opt 6.04 Duplicate certificates. Duplicates of original certificate or renewal certificate may be obtained from the secretary of the board upon payment of the fee specified in sec. 440.05(7), Stats., and the return of the original certificate or submission of a sworn statement that the original was destroyed and is no longer in existence.

Section Opt 7.05 of the Wisconsin Administrative Code is repealed.

Section Opt 7.07 of the Wisconsin Administrative Code is repealed.

Chapter Opt 8 of the Wisconsin Administrative Code is repealed.

Chapter Opt 9 of the Wisconsin Administrative Code is repealed.

Section Opt 11.04 of the Wisconsin Administrative Code is amended to read:

Opt 11.04 Hearing. If a hearing is requested by the applicant, the board shall conduct such hearing as soon thereafter as is practicable. Hearings under this chapter shall be conducted as set forth in the rules promulgated under sec. 440.03(1), Stats.

The rules, amendments, and repeals contained herein shall take effect on the first day of the month following their publication in the Wisconsin administrative register as provided in sec. 227.026(1), Wis. Stats.
