

Stats., and in accordance with the provisions of ss. 792 and 928, Chapter 418, Laws of 1977, (creating s. 440.03, Stats.), and RL-2, Veterinary Examining Board hereby repeals rules as follows:

Chapter VE 1 and Section VE 5.06 of the WISCONSIN ADMIN-ISTRATIVE CODE are repealed.

Pursuant to authority vested in the Veterinary Examining Board by sections 15.08, 227.014, and 227.02, Wis. Stats., the Veterinary Examining Board hereby amends rules respectively as follows:

I. Section VE 3.03 of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

VE 3.03 Board action. The Board may reprimand the licensee or deny, suspend, limit or revoke the license of any person to practice veterinary medicine who engages in any of the acts prohibited in VE 3.02.

II. Section VE 6.03 of the WISCONSIN ADMINISTRATIVE CODE is repealed and recreated to read:

VE 6.03 Disciplinary Actions. When a complaint is filed against a certified animal technician, the procedural rules in RL-2, Wis. Adm. Code shall apply. The Board may reprimand the animal technician or deny, suspend, limit or revoke the certificate.

The amendments contained herein shall take effect on May 1, 1979.

Pursuant to the authority vested in the Veterinary Examining Board by Sections 15.08(5) Wis. Stats., the Veterinary Examining Board hereby amends and adopts the rules as follows:

VE 3.02(3) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

VE 3.02 (3) Gross negligence, fraud or deception in the inspection, examination, testing or reporting of test results in violation of the Wisconsin Department of Agriculture, Food and Consumer Protection Chapter 95, Wis. Stats. 1977 and Chapter AG 10 Wisconsin Administrative Code, January 1, 1978, or United States Department of Agriculture 9 CFR - Chapter 1 Animal and Plant Health Inspection Services, Department of Agriculture, January 1, 1978, applicable on the date the tests were made or should have been made or interstate, intrastate or international movement of animals. Gross negligence under this subsection includes the following acts but is not limited to them:

(a) Serology testing

 Accepting and submitting blood which is not drawn or properly identified by an accredited veterinarian.
Screening blood samples and only submitting negative samples to state laboratory.

3. Allowing an unauthorized person to conduct the test.(b) Intradermal testing

1. Failure to properly administer and interpret the test.

2. Failure to properly identify animal being tested.

(c) Interstate - Export Health Certificates

1. Contain data not based on fact.

2. Failure to submit copies to Wisconsin Department of Agriculture - Animal Health Division within time specified.

VE 3.02 (6) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

(6) Conviction of a crime the circumstances of which substantially relates to the practice of veterinary medicine.

Chapter VE 4 Denial of License (Title) and sections VE 4.01, VE 4.02 and VE 4.03 of the Wisconsin Administrative Code are amended to read:

#### DENIAL OF LICENSE OR CERTIFICATE

VE 4.01 Denial. An applicant who has not previously been licensed or certified in this state shall be denied a license or certificate if the applicant does not meet the standards or requirements for licensure or certification set forth in Chapter 453, Wis. Stats., or rules promulgated thereunder.

VE 4.02 Notice and Examination Review. (1) Upon denial of an application for a license or certificate, the board shall notify the applicant, stating the reason for denial, and that the applicant has the right to a hearing if written request is received by the board within 30 days after service of the notice of denial.

(2) Unsuccessful applicants may review their written exam at the board office during regular office hours upon written request within 30 days after notice of denial.

VE 4.03 Service. Service of the notice of denial shall be made by certified mail, return receipt requested, addressed to the applicant at the latest address filed by the applicant in writing with the board. Service by certified mail is complete on the date of mailing.

VE 7.03(2) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

VE 7.03(2) The personal use, misuse or sale other than for medical treatment of animal patients, of drugs listed in the U.S. Controlled Substances Act of 1970, as amended, or Chapter 161, Wisconsin Statutes 1977. Not included are drugs prescribed by a physician for use by the certified animal technician at any given time.

The amendments contained herein shall take effect on May 1, 1979.
