Analysis Prepared by Department of Natural Resources

The following order repealing sections NR 25.09, NR 25.13(1), (2), (4) and (5), and NR 25.15 is being promulgated so that Natural Resources Board Order No. F-7-79 correctly reflects the action taken by the Natural Resources Board when chapter NR 25, Wis. Adm. Code pertaining to commercial fishing on outlying waters was approved. The sections pertaining to crew identification (NR 25.09), handling and disposition of fish (NR 25.13) and reserve waters (NR 25.15) are no longer pertinent and it was the Board's intention that these sections be repealed when other sections were renumbered to use these section numbers.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by sections 23.09, 23.11, 227.014 and chapter 29, Wisconsin Statutes, the State of Wisconsin Natural Resources Board hereby repeals rules as follows:

SECTION 1 - Section NR 25.09 is repealed.

SECTION 2 - Sections NR 25.13 (1), (2), (4) and (5) are repealed.

SECTION 3 - Section NR 25.15 is repealed.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on April 26, 1979.

The rules contained herein shall take effect upon publication.
